The 11th Annual General Meeting of the Presbytery of Western Australia was held on Saturday 5 November at The Billabong Uniting Church. Lay and ordained members from our congregations and faith communities from around the Presbytery came together for fellowship and to discern the direction of the business of the Presbytery.

Opening worship and induction

Uniting Aboriginal and Islander Christian Congress (Congress) WA Regional Committee representative, Rev Sam Dinah gave the welcome to country in both English and the tongue of his Nyungar people.

Worship, led by The Billabong, began with a well-known song, 'You are my vision' sung with gusto and a modern, upbeat twist.

Rev Cathie Lambert shared a brief insight from the book *The Naked Now: Learning to See as the Mystics See* by Richard Rohr. That to feel, imagine and sense the underlying mystery is to use our first, second and third eyes to assist us to see the moment and attain insight. Cathie challenged the members of Presbytery to view the work of God in our world and live God's covenant written on our hearts.

Deputy General Secretary, Rev Dr Ian Tozer's induction to the placement was conducted during worship. Ian's brief response quoted Rowan Williams, "The love of God is a love that goes where God is not supposed to be, where God is not imagined or conceived to be ... God's love is recognisable precisely as the love which goes where it has no business to go and which lives, blossoms and acts in the place of the curse, in the place where God is forgotten."

Opening Worship



Justine Wall's ordination approved

A joyful decision was the approval of the ordination of Justine Wall as a Minister of the Word, subject to obtaining a Certificate of Completion of Studies and being called to a placement.



Justine was unable to attend Presbytery, so her message was read. Justine shared her battle with God from childhood into her twenties, when she defined herself as an atheist. However, she was drawn to sacred places and to people of faith.

"One afternoon at Murdoch University, for no apparent reason, I felt compelled to knock on the door of the University chaplain. After listening to my long list of objections to Christianity and the church, the chaplain asked me what had brought me to his door, and I answered, God had. I was amazed at my own words," said Justine.

From this point, her faith continued to grow and deepen and she became Head of Religion, Ethics and Values at an Anglican girls' school. Justine experienced ministry for the first time when she filled in, after the school chaplain left, taking chapel services. She felt God's hand upon her and knew this was her purpose in life.

Justine has been the chaplain at Tranby College for the past six years. She has been blessed with the support of many Uniting Church people who have encouraged her on her journey towards ordained ministry. In particular, Rev Marion Millin, Rev Ivan Clarke and the congregation of Melville Uniting Church, and the chaplains of the WA Uniting Church schools.

"My path to ordination has not always been clear, but I do believe God has searched me out, hemmed me in and laid a hand upon me," said Justine.



New Structure

General Secretary, Rev David de Kock, summarised his report, 'Towards an understanding of the separation of the Synod of Western Australia and the Presbytery of Western Australia and/or any future presbyteries in Western Australia'.

The Uniting Church WA has been moving towards a new structure which will enable two or more Presbyteries to exist with the Synod. Factors include the establishment of a Congress Presbytery, unfairness in dealing with matters of complaint, and confusion over the separate roles and responsibilities of Synod and Presbytery.

The implementation of the new structure followed a two-step process with agreement required from both the Synod of Western Australia and the Presbytery of Western Australia.

At the 40th Annual Meeting of the Synod of Western Australia held in September, the new structure and By-Laws for Synod were agreed by consensus to be enacted at the rising of the 11th Annual General Meeting of the Presbytery of Western Australia on 5 November. Essentially, the changes were the cessation of General Council, the change in function, powers and responsibility of the Standing Committee and the establishment of a Placements Commission.

At the 11th Annual General Meeting of the Presbytery of Western Australia, the new structure for the Presbytery of Western Australia was introduced. Essentially, the changes were the creation of a Presbytery Standing Committee, Pastoral Relations Committee, Presbytery Property Committee, as well as the election of a Chairperson, Secretary and Treasurer. The changes for both Synod and Presbytery were enacted simultaneously at the rising at the rising of the 11th Annual General Meeting of the Presbytery of Western Australia.

The joint commissions of the Synod and Presbytery:

Business Commission; Church Law Commission; Nominations Commission and Liturgy Commission, will derive a great deal of synergy from combining work across the committees. In addition, if and when other presbyteries are added, there will be cross-presbytery committees to serve across the presbyteries.

Presently, the Commission for Education for Discipleship and Leadership (CEDAL) will remain a Presbytery Committee until it can be set-up as a Synod body.

The changes to the By-Laws of Synod and Rules of Presbytery are largely cosmetic and bring the church in Western Australia back to the requirements of the Regulations of the Uniting Church in Australia.

First Third Ministry

Rev Hollis Wilson, First Third Working Group chairperson, Rev Brenton Prigge, First Third Specialist South-West and Janine McDonald, First Third Officer gave a presentation to the Presbytery.

Brenton outlined how Busselton has seen progress in a truly unique context of almost eight years of uninterrupted First Third Ministry.

Eight years ago, Busselton was similar to many other Uniting Church congregations. On a Sunday, attendance averaged 60 people, most of retirement age. One or two families attended sporadically to bring children to Sunday School. There were no teenagers or young adults.

However, alongside the traditional Sunday worship, Busselton had a strong outreach program including a community op-shop and low cost food shop, but the connection between the church and the outreach programs were very tenuous and the gap was growing wider.

Brenton said, "The picture 8 years later is very different with attendance on Sundays growing to an average of more than 80 and it's not uncommon to have more than 100. This may not seem like huge growth, except when you factor in the two or three dozen funerals that have taken place over this period and the subtle, but definite

shift in the age demographic. We still have people in the second third of life, but we now have a solid core of young families with children, as well as a small, but faithful, contingent of young adults. Hardly a week goes by that we don't have new people putting their toes in the water."

Sunday morning worship begins with all ages together led by a worship team of primarily teens. Youth worship time is separated into Godly Play for children under 12 and Youth Study time for young teens.

"These are healthy signs for a culture of faith formation and faith sharing. What you see on Sunday is only the tip of the iceberg of what we call the 'family', the people connected to the life of the Busselton Uniting Church," said Brenton.

Seldom is the church building empty during the week with a playgroup run by the church as a service to the community, Fresh Expressions in Messy Church services in Busselton and Nannup, and Followers' Inn café-style, low-cost lunches two days per week to foster relationships with those most in need in the community.

Community engagement is Busselton's greatest strength with the miraculous work of Julie Parry, Outreach Co-ordinator and Rev Andrew Broadbent bridging the divide between church members and the outreach community.

"We are a family that engages people of all ages, but people of all ages within the family are doing the engaging. We see ourselves as a family of God's people on a journey, some have been on the journey for a while, and others are just beginning. Some come to church on Sunday, others to Messy Church, and others are just beginning to ask faith questions, but we are all part of the family in the way we engage in the work and life of the church. Many of these ministries are now lay led and volunteer based, which frees up Andy and me to be resource people, mentoring, training and encouraging the people who do the real work," said Brenton.

Hollis outlined the redevelopment of the Uniting Church Campsite since its closure back in 2011/12 and invited everyone to attend the Uniting Church Campsite commissioning service at 12.30pm on Saturday 10 December at 140 Caves Road, Busselton.

Janine shared reasons to celebrate in an overview of her work as First Third Officer. These included the redevelopment of the Uniting Church Campsite; 160 campers, including the leadership development team at Kids Camp Out, and 11 Western Australians funded by First Third to attend the National Young Adult Leader's Conference (NYALC).

In January 2017, First Third Ministry will host 18 young adults on the WA Tour to the Yurora NCYC (National Christian Youth Convention) for young people aged 16 to 25 to be held at The Tops Conference Centre, NSW from Sunday 8 to Thursday 12 January 2017.

First Third Ministry Review

Travis Windsor, First Third Review convenor briefly highlighted some of the results of the review gathered through focus groups and an online survey.

Presbytery Standing Committee will carefully consider the content of this significant report and will report back to the 12th Annual General Meeting of the Presbytery of Western Australia to be held on Saturday 20 May 2017.

Deliberations and decisions

Candidates for Ministries Committee extension

The Presbytery agreed by consensus to give permission for Rev Anne McAndrew to serve as a member of the Candidates for Ministries Committee (CMC) for one more year, noting that Anne has already served on this Commission for the past 10 years.

CMC believes it will be helpful for Anne to continue for a further year on CMC to mentor and support new members of the committee.

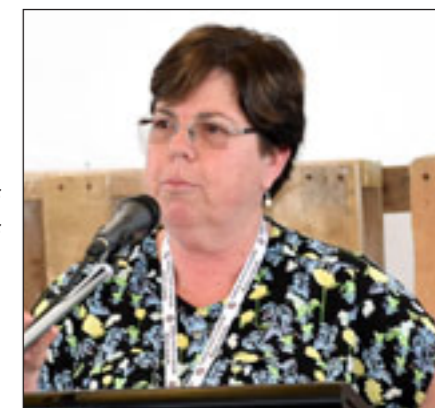
Reception of reports to the Presbytery

The Presbytery accepted by consensus that in future, reports to the Presbytery will be received individually, rather than en bloc, to enable issues and questions to be addressed and discussed more effectively.

Presbytery of Western Australia structure

The Presbytery agreed, in principle, that from the rising of the 11th Annual General Meeting of the Presbytery of Western Australia, the structure of Presbytery, including its separate Chairperson,

Secretary, and Treasurer, be separated from the Synod as outlined in the Regulations.

Later in the meeting, Rev Lorraine Stokes was elected chairperson of the Presbytery of Western Australia and Rev Dr Ian Tozer was elected secretary. No nominations were received for the position of Presbytery Treasurer, so this position remains vacant.

Strategy and Mission Planning Committee

The Presbytery agreed by consensus to set aside the section of the new Presbytery of Western Australia Rules to establish a Mission Planning subcommittee of the Pastoral Relations Committee (PRC) and continue with the current Rules for Strategy and Mission Planning Commission (S&MPC), to allow time for further consultation about future directions, with a proposal to come to the 12th Annual General Meeting of the Presbytery of Western Australia to be held on Saturday 20 May 2017. Presbytery also accepted the nominations for the Mission Planning Subcommittee as the nominations for S&MPC.

Review of the Regions

The Presbytery agreed by consensus that the Presbytery Standing Committee undertake a review to clarify the roles, structure and purposes of Presbytery Regions and Regional Pastors and report to the 12th Annual General Meeting of the Presbytery of Western Australia to be held on Saturday 20 May 2017. The existence of a report on regions prepared by Placements Unit Manager, Rev John Barendrecht was noted.

Presbytery Rules

The Presbytery agreed by consensus to request the Presbytery Standing Committee make the review of the new rules regarding Presbytery structure, in consultation

with Presbytery Committees, a priority over the next six months in order to bring a report to the 12th Annual General Meeting of the Presbytery of Western Australia to be held on Saturday 20 May 2017.

Church Law

The Presbytery agreed to adopt the following Rules of the Presbytery: 1.1 Introduction of Rules of the Presbytery; 1.2 Enactment amendment and repeal of Rules; 2.1 Membership of Presbytery; 2.2 Presbytery meetings; 2.3 Presbytery regions; 2.4 Officers of the Presbytery; 2.5 Election of Presbytery Bodies; 3.1 Presbytery Standing Committee; 3.2 Pastoral Relations Committee (excluding sections 3.2.27 to 3.2.28 which relate to the Mission Planning Subcommittee); 3.3 Candidates for the Ministries Committee; 3.4 Property Committee; 3.5 Commission for Education for Discipleship and Leadership; 4.1 Congregational Community Services Committee; 4.2 Rural Ministry Committee; 4.3 First Third Committee; 4.3 Multicultural and Cross-Cultural Committee and 4.5 Liturgy Committee.
