The Opening Worship was conducted at Scotch College Chapel at 76 Shenton Road, Swanbourne at 7.00pm on Friday, 9 September 2022, and the business sessions of the 46th Annual Meeting of the Synod of Western Australia were conducted at Scotch College on Saturday 10 and Sunday 11 September 2022.

CONSTITUTION OF THE MEETING OF SYNOD

Opening Worship Friday 9 September 2022

The opening worship was constituted by an act of public worship led by the Moderator, Susy Thomas at 7.00pm on Friday 9 September 2022.

Rev Mitchell Garlett welcomed the Synod to country on behalf of the Wadjak people of the Nyungar nation.

Music was provided by Eliesa and the Multi-Cultural Youth.

SYNOD BUSINESS MEETING - SATURDAY 10 AND SUNDAY 11 SEPTEMBER 2022

WELCOME, INTRODUCTIONS AND HOUSEKEEPING

The General Secretary, Rev Dr Andrew Williams welcomed everyone to the meeting and provided some housekeeping guidelines including facilities and amenities. He welcomed the Moderator's Chaplain, Rev Nalin Perera and explained the conditions associated with the voting cards and reminded members to keep them for the two days.

WELCOME BY THE MODERATOR

Moderator, Susy Thomas welcomed everyone and opened the meeting in prayer. She acknowledged the Noongar people past and present, the Traditional Owners of the land on which the Synod meeting was held. This was followed by a video presentation of The Blessing (Evaluation Worship).

WELCOME TO COUNTRY

The Moderator, Susy Thomas welcomed Rev Mitchell Garlett to the stage. Rev Garlett acknowledged the Noongar people past and present, the Traditional Owners of the land on which the Synod meeting was held.

WELCOME TO SCOTCH COLLEGE

Dr. Alec O'Connell, Headmaster of Scotch College welcomed everyone to the meeting and acknowledged the traditional owners of the land. He said Scotch College was honoured to host the Synod meeting this year and looked forward to future relationships with the Uniting Church.

SATURDAY DEVOTIONS

Rev David Ferguson, Presbytery Officer/Secretary, welcomed members to Synod and presented his devotion. Rev Ferguson based his devotion on Overflow with Hope.

PROCEDURAL PROPOSAL 1 - GENERAL SECRETARY

The General Secretary, Rev Dr Andrew Williams referred to Proposal One and presented "The Decision making at Synod Video". He provided a short introduction and presented each section of the Proposal. Ballots and Nominating Committee were reminded that any member with a conflict of interest with any ballot, were required to stand aside.

Resolution 1/2022 The Procedural Proposal 1 was received and accepted by consensus subject to amendment 2 (c).

Resolution 2/2021 The Moderator's Report was received and accepted by consensus.

SYNOD COMMISSION REPORTS

Rev Dr Andrew Williams presented the Synod Commission Reports. The reports are presented by *Consent Agenda*. Reports were taken as read and presented en bloc. Opportunity was given to separate any reports for discussion if required. **Note:** Consent Agenda can approve all reports in one action rather than filing motions on each item separately.

Resolution 3/2021 The Synod Commission Reports were presented en bloc and taken as read. Reports were accepted by consensus with the following amendment:

PROPERTY TRUST PROPOSAL 2

Rev Des Cousins presented the Property Trust Proposal 2. He provided a brief summary explaining the rationale behind the proposal. Rev Cousins said a review of the Property Trust and Special Purpose Funds had been undertaken. After the review, the committee decided that any property decision needs to be put forward to the Synod for approval. He said, previously property decisions had been made by the Property Trust.

Resolution 4/2022 The Property Trust Proposal 2 was received and accepted by consensus as follows:

- 2. upon application of the Uniting Church in Australia Property Trust (W.A.), pursuant to s 25 of the Act, to approve the transfer of the balance of the Alison Mary Baird Bequest to the UCA (WA) Foundation Trust on the grounds that the specific trust has already been affected and the Foundation Trust is suitable vehicle to hold general benefit funds.
- 3. upon application of the Uniting Church in Australia Property Trust (W.A.), pursuant to s25 of the Act, to approve the transfer of the balance of the Mayflower Homes Trust to the UCA (WA) Foundation Trust on the grounds that the specific trust is now impossible.
- 4. upon application of the Uniting Church in Australia Property Trust (W.A.), pursuant to s25 of the Act, to approve the transfer of the balance of the William Ellis Memorial Fund to Trinity Residential College (as the successor to Kingswood College) for an appropriate College purpose on the grounds that the fund is inadequate for its original purpose.
- 5. upon application of the Uniting Church in Australia Property Trust (W.A.), pursuant to s25 of the Act, to approve the transfer of the balance of the Neville King Book Award to Trinity Residential College (as the successor to Kingswood College) for an appropriate College purpose on the grounds that the fund is inadequate for its original purpose.

Rev Sharon Hollis, Moderator and Colleen Geyer, General Secretary of Assembly greeted members of the Western Australian Synod and wished everyone a successful meeting. They presented their report by video.

The General Secretary, Rev Dr Andrew Williams addressed the Synod and took the opportunity to thank his predecessors Rev Andrew Syme and Rev John Dunn for standing in during the COVID period that prevented him from commencing in early 2022. Rev Dr Williams provided an update since he commenced at the Uniting Church office in April 2022. He spoke about the culture, the structure of the church, processes of committees and Hope. Rev Dr Williams responded to questions from the floor.

Rev Dr Williams continued to present his report and sub reports.

Resolution: 7/2022 The Synod Standing Committee Report and Sub Reports were presented en bloc and taken as read. Reports are accepted by consensus.

RECOGNITION OF SERVICE – SHEENA HESSE (ARCHIVIST)

Rev Dr Andrew Williams presented a recognition of service for the Uniting Church former Archivist, Sheena Hesse.

Sheena Hesse joined the Uniting Church WA Archive as the Honorary Archivist in 2003 and oversaw significant progress until her retirement some 18 years later in 2021.

Perhaps one of the more challenging projects that Sheena oversaw in her time at the Archive, was the transportation of the entire contents of the Archive from its location at Westminster house, to its current location in Edward Street in 2011.

Once housed in their new premises, Sheena would continue her dedication to collating, conserving, and making available, the records produced by the Congregational, Methodist, Presbyterian, and Uniting Church for future generations to come. Sheena led a team of committed volunteers, many who continue to volunteer at the Archive today.

Sheena's dedication to the Archive throughout those 18 years, has ensured that the records of the Uniting Church in WA today, exist as evidence of the Uniting Church's memory and identity. An enormous legacy from Sheena and one for which we will be forever grateful for and inspired by.

Rev Dr Katalina Tahaafe-Williams presented the Bible Study on Hope and Joy.

REVISED STRATEGIC DIRECTIONS FOR THE UNITING CHURCH IN WA - REPORT 36

Rev Hannes Halgryn (Associate General Secretary Strategy), presented the first part of the Revised Strategic Directions for the Uniting Church in WA. He provided a summary of the framework and explained the idea of a QR code for table discussions for members to use during the session and provide feedback. He said this process reminds us that as a church we are called to do this together and work collectively and be responsible and accountable.

Rev Hannes Halgryn led table discussions with live polling opportunities presented. Polling remained open through the evening and the results would be submitted in the Sunday session of Synod

RESOURCES COMMISSION REPORT 17

Chris Walker, Chair of the Resources Commission presented the Resources Commission Report. He explained three main points:

- Investment Fund Entrust Private Wealth Management are appointed to consult and manage Uniting Church Funds who maintain the Uniting Church's current operational model and services.
- 2. Insurance and Risk Office The Insurance Investment suffered reduction of income due to Schools choosing to leave the Uniting Church Insurance because of Redress.
- 3. Financial Risk Financial risks arising from Redress and potential historical sexual abuse.

Chris Walker acknowledged the work of the Resources Commission, the Property and Services Committee, Investment and Corporate Finances, Insurance and Risk and the Uniting Church staff who have been involved.

Resolution: 9/2022 The Resources Commission Report was received and accepted by consensus

RESOURCES COMMISSION PROPOSAL 3

Rev Des Cousins presented Proposal 3 and explained the rationale. He responded to questions from the floor.

It was noted that the establishment of a Special Committee includes both Synod and Presbytery representation. After discussion, a proposal was put forward for the Special Committee to allow the power to co-opt two (2) further members who may bring specialist knowledge or skills.

Proposal 3

Resolution: 10/2022 The Resources Commission Proposal 3 was received and accepted by agreement as follows:

That the Synod resolves:

- 1. to establish a Special Committee to review the structure and role of the Resources Commission, with authority to receive written submissions from and consult with interested bodies and persons (including staff).
- 2. to request the Special Committee to present an interim report to the Synod and Presbytery Standing Committees by end of March 2023 and a final report to Synod 2023 with recommendations for new or varied structures and any consequential new or amended Bylaws.
- 3. The review to include a consideration of:
 - the relationships between the various bodies involved in the oversight of the resources
 of the Church (including finance, property, investments and insurance), the processes by
 which decisions are made and where final authority lies for decision making;
 - the relationship between staff and governance bodies, in particular the matters which
 relate to governance and should be considered and determined by governance bodies,
 and those matters which are purely operational and can be dealt with by senior staff;
 - an appropriate process for preparing the Church budget in a widely consultative way to reflect the Church's missional and strategic priorities and which allows for decisions to be made by appropriate governance bodies;
 - the need for a sustainable governance model for the property and finance resources of the Church, which complies with the UCA Regulations, ensures that councils and committees of the Church make appropriate governance decisions in a timely manner and is able to be maintained in a Church with fewer people resources for committees and councils; and
 - ensuring that the decisions about finance and resourcing within the Church are appropriately focussed on achieving missional and ministry outcomes and are informed by those councils within the Church that hold primary responsibility for those functions.

- 4. Appoint the following to comprise the membership of the Special Committee:
 - General Secretary (Convener)
 - Presbytery of WA Chair (or representative)
 - Resources Commission Chair (or representative)
 - UCA Property Trust (WA) Chair (or representative)
 - Presbytery Property Committee Chair (or representative)
 - Presbytery Finance Committee Chair (or representative)
 - Church Law Committee Chair (or representative) and
 - Two (2) further members with specialist skills appointed by Special Committee

With his departure the Resources Commission and Property Services will have an experience gap that will be difficult to fill. BUDGET REPORT 4

Rev Dr Andrew Williams presented the Budget Report. He was joined by Peter Hollins, CFO of the Uniting Church, Chris Walker, Chair of the Resources Commission, David Beards, Member of the Investment and Finance Committee and Alison McCubbin, Member of Synod Standing Committee. Rev Dr Andrew Williams explained the process of how the budget report and proposal was prepared. He reminded members that the work involved in the process included a Workshop Day, Budget and Finance Committee meetings, the involvement of the Resources Commission, two Synod Standing Committee meetings, a Joint Synod and Presbytery Standing Committee meeting and another sub-committee working group to look at the figures and to get to this point of offering a balanced budget.

Rev Dr Andrew Williams provided a Power Point presentation and explained the details. He responded to questions from the floor and after some discussion it was agreed to the following:

A proposal that a that a facilitation group comprising of Rev Mark Illingworth, Deborah
Marshall, Peter Hollins, Alison McCubbin meet to discuss and provide a new proposal of how
to present the budget going forward.

Resolution: 12/2022 The Synod accepts by consensus to appoint a facilitation group comprising of Rev Mark Illingworth, Deborah Marshall, Peter Hollins, and Alison McCubbin to present a new Budget Proposal 4.

JOINT PROPERTY STRATEGY GROUP REPORT 11

Bob Hunt, Chair of Joint Property Strategy Group presented the report and responded to questions from the floor. It was noted that Synod acknowledges the sense of urgency to obtain funds for redress with the sale of properties for at least \$3.5 million for the next 12 months. He itemised the six proposals.

Resolution: 15/2022 The Joint Property Strategy Report 11 was received and accepted the report.

JOINT PROPERTY STRATEGY GROUP - PROPOSAL 8

It was noted that the following recommendations were put forward for discussion and decision. That the Synod:

- 1. Being mindful of Presidential Ruling 26 and 29 undertake further work in developing and implementing the Property Strategy as per Regulation 4.6.3 and 4.11.10. *Approved*
- 2. Confirm the variations to Resolution 31/2021 as highlighted in Section 4.2 of the Report. Approved *subject to noting the variations*. See the excerpt below:

EXTRACT FROM JOINT PROPERTY STRATEGY GROUP REPORT 11

4.2 Variations to SYNOD Resolution 31 (4) - Proceeds of Sale of Properties

After additional advice and updated information, the following variations (highlighted in yellow) were agreed by the Synod Standing Committee to the list of areas that the proceeds of the sale of properties are to be distributed:

- 4) Develop a policy of how proceeds from sale of properties can be utilised for the following purposes:
 - At least \$10M to pay for Redress claims in the next $\frac{7}{4}$ 3 years.
 - Provision of funds towards the work of the Uniting Aboriginal and Islander Christian Congress (UAICC) WA Regional Committee. To be 1% of the net proceeds of the sale of property as per the current arrangement.
 - Provision of funds to enable new mission to develop, such as funding for new and innovative ministry positions.
 - Provision of funds to purchase property in new areas or to develop existing properties so they are better able to meet missional priorities.
 - Increase funds under management of the Uniting Church WA.
 - Provision of funds towards the work of the Synod Property Services Fund. To be 9% of the net proceeds of the sale of property as per the current arrangement.

Recommendation 2 - Confirm the variations to Resolution 31/2021 as highlighted in Section 4.2 of the Report.

- 3. Develop housing strategies for Ministers in placement with the Synod and Presbytery. Approved
- 4. Adopt the draft Policy document for Distribution of the Proceeds of the sale of property at Appendix B of the Report. *Approved*

- 5. Thank and discharge the JWG and request the Executive Property Officer to develop a plan of how the Property Strategy is to be developed and implemented. The plan is to ensure that there will be:
 - Consultation with the Congregations
 - Involvement of the Synod and Presbytery Property Committees
 - Oversight by the Synod and Presbytery Standing Committees Approved
- 6. The Plan is to be prepared in consultation with Synod and Presbytery Standing Committees and subject to approval by the Synod Standing Committee. *Approved*
- 7. Develop the process for managing and allocating funds for new mission proposals subject to approved by the Synod Standing Committee. *Approved*

COVENANTING COMMISSION PROPOSAL 10

Rev Dr Alison Longworth, member of the Covenanting Commission presented Proposal 10 and explained the rationale.

That the Synod:

- 1. Re-affirm our commitment to the Covenant made at the 7th Assembly between the Uniting Church in Australia (UCA) and the Uniting Aboriginal and Islander Christian Congress (UAICC), and our understanding that this relationship is at the heart of the Uniting Church in WA.
- 2. Enter into the process of developing a Covenanting Action Plan, developed by a task group appointed by the Synod Standing Committee in consultation with Uniting Aboriginal and Islander Christian Congress WA Regional Committee and the Covenanting Commission.

Resolution: 20/2022 The Covenanting Commission Proposal 10 was received and accepted by consensus.

INTERNATIONAL PARTNERSHIP & DEVELOPMENT COMMISSION (IPDC) REPORT 10

Kerry Povey, Social Justice member presented the Social Justice Report and provided an update. Dr Sureka Goringe, National Director of UnitingWorld sent a message to Synod. She sent through a Certificate of Appreciation to the Synod of Western Australia and thanked them for their support from 410 individual members and 21 congregations. Dr Goringe said the contribution during 2022 has enabled UnitingWorld and its partners to provide clean water, leadership, education and other projects that changes people's lives.

Kerry Povey completed her summary and thanked the Uniting Church team of Geoff Bice, Executive Officer Social Justice and Wendy Hendry, Social Justice Officer for their continued work.

Resolution: 21/2022 The International Partnership & Development Commission (IPDC) Report 10 was received and accepted by consensus.

SOCIAL JUSTICE REPORT 18

Mark Brisbane, Chair of the Social Justice Commission presented the report and acknowledge the work of the Social Justice Team, including Geoff Bice and Wendy Hendry. A video was presented.

Resolution: 22/2022 The Social Justice Commission Report 18 was received and accepted by consensus.

SOCIAL JUSTICE CLIMATE CHANGE PROPOSAL 5

The Social Justice Commission (SJC) propose for the Synod to resolve:

- 1. To acknowledge:
 - a) The Assembly's resolution "A call to action for climate justice: listening to First Peoples wisdom".
 - b) The Synod's previous resolutions calling on Governments to take actions to keep within a 1.5°C global temperature rise, by urgently transitioning away from fossil fuels and towards renewable energy.
 - c) The Synod's "Green Church" policies adopted in 2014.
- 2. To commit to becoming a net zero emissions Synod by 2030.
- 3. To establish a net zero emissions church working group, reporting to Synod Standing Committee, to gather data on commitments to greenhouse gas emission reduction made across the life of the Synod, and coordinate progress towards those commitments.
- 4. To encourage and resource the Presbytery, congregations, schools and agencies to reach net zero emissions by 2040, preferably by 2030.
- 5. To call on the Federal Government to:
 - a) Create an independent environmental assessment body and ensure that the full climate impacts of any projects are included in environmental assessment processes.
 - b) Not provide any subsidies or financial assistance to fossil fuel projects or related infrastructure.
 - c) Commit to and advocate for a Fossil Fuel Non-Proliferation Treaty at an international level.
- 6. To call on the State Government to:
 - a) Commit to a state-wide 2030 emissions reduction target to align with global commitments to keep within a 1.5°C global temperature rise.
 - b) Not approve any new or expanded fossil fuel projects in Western Australia.

Bob French, member of the Social Justice Commission presented Proposal 5 Climate Change. Geoff Bice, Executive Officer Social Justice responded to questions from the floor.

Resolution: 23/2022 The Climate Change Proposal 5 was received and accepted by consensus.

PROPOSAL 6 HOMELESSNESS & HOUSING

John Berger, Executive Officer, Caring Agencies presented Proposal 6 Homelessness and Housing. Rev Sophie Lizares, member of Social Justice Commission was joined by John Berger, Executive Officer Caring Agencies who presented the Homelessness & Housing Proposal.

The Social Justice Commission (SJC) propose for the Synod to resolve:

- 1. To acknowledge:
 - a. the longstanding advocacy and service from congregations, the Synod, Assembly, and UnitingCare bodies in regard to care for the most vulnerable in our society, provision of social housing, and homelessness support services.
 - b. the 2020 resolution of the Synod calling for an increase in social housing and implementation of minimum energy efficiency standards for social housing and rental accommodation.
- 2. To request the Synod Property Services Team to consider opportunities for social housing options across the Uniting Church WA's property portfolio and to collaborate with stakeholders to pursue viable options.
- 3. To call on the Federal Government to:
 - a. Fast track their commitments to build 30,000 social and affordable homes over 3 years instead of 5 and immediately invest in a program of spot-purchasing and repurposing of property to make a further 15,000 social and affordable homes available each year over the next 3 years.
 - b. Increase their commitments to finance housing in remote Indigenous communities.
 - c. Increase their commitments to finance transitional housing and crisis support for people at risk of homelessness, in particular, women and children fleeing domestic and family violence.
 - d. Increase the Commonwealth Rent Assistance payment to prevent people entering homelessness.
 - e. Increase funding to homelessness services.
- 4. To call on the State Government to:
 - a. Allow and incentivise secure leasing models for mainstream tenancies.
 - b. End no-cause evictions to reduce the risk of people becoming homeless.
 - c. Invest in early intervention programs for children and young people at-risk of homelessness, with targeted, culturally appropriate responses for people involved in child protection, and juvenile and adult justice systems.
 - d. Increase funding to homelessness services.

Resolution: 24/2022 The Homelessness and Housing Proposal 6 was received and accepted by consensus.

PROPOSAL 7 - ONLINE GAMBLING

Mark Brisbane, Chair of Social Justice Commission presented the Online Gambling Proposal 7

The Social Justice Commission (SJC) propose for the Synod to resolve:

- 1. To call on the Federal Government to:
 - a. Ban the use of credit cards and digital wallets for online gambling
 - b. Ban all gambling advertising, including partnerships and online advertising.
- 2. To call on the State Government to:
 - a. Increase funding and training to financial counsellors in Western Australia to support people experiencing gambling related difficulty
 - b. Ban all inducements that encourage people to gamble
 - c. Legislate a duty of care for gambling businesses to allow them to be prosecuted for failing to take reasonable steps to prevent harm from gambling.

Resolution: 25/2022 The Social Justice Commission Proposal 7 Online Gambling was received and accepted by consensus.

Rev Nalin Perera closed the meeting in prayer.

SUNDAY 11 SEPTEMBER 2022

Sunday Worship and Holy Communion was held. The Moderator, Susy Thomas and Rev Dr Christine Sorensen led the Service. Rev Dr David Ferguson, Presbytery Office was farewelled with a presentation by Alison Xamon, Chair of Presbytery. Music and singers were provided by Chris Lock, Rev Andy Broadbent, and the music team.

MORNING TEA

DISABILITY ACCESS AND INCLUSION SESSION

Cindy Gorton, Executive Officer Culture of Safety, welcomed Rev Dr (Deacon) Andy Calder, Disability Inclusion Advocate in the Synod of Victoria, who joined the meeting via Zoom.

Rev Dr Andy Calder presented an overview and provided information on the Draft Disability Access and Inclusion Policy. Cindy Gorton welcomed Robbie Muir to the stage who was joined by Rev Steve Francis. Robbie explained some of the issues and difficulties relating to the needs of those with a disability.

Cindy Gorton invited members for question time and Rev Dr Andy Calder provided responses. A table discussion was held, and Synod members were asked to provide feedback. The feedback was collected and taken away to be collated. The following questions were circulated: Table Discussion Questions:

- (1) How can we be more inclusive what are the barriers (physical, attitudinal and communication wise?
- (2) What can the Presbytery / Synod do to make this gospel demand a reality in our communities.

Cindy Gorton referred to an Interfaith Litany for Wholeness written by Rev Kate Chipps and adapted by Ginny Thornburgh. Reproduced with permission from That All May. This was read by Robbie Muir and Cindy Gorton and responses were captured by Synod members.

Resolution: 26/2022 The Disability Access and Inclusion presentation was noted.

Chris Hall, CEO and Maree Arnason, Chair of Juniper were present. Chris Hall provided a response on behalf of the Caring Agencies on the topic of "Upholding our status as Uniting church agencies". Good Sammy Enterprises (GSE)

Good Sammy Enterprises

Kane Blackman, CEO and Trent Bartlett, Chair of GSE were present. Kane Blackman provided a response on behalf of the Caring Agencies on the topic of "Being a primary vehicle of the church in bringing God's mission to the world".

Beananging Kwuurt Institute (BKI)

Katina Law, Chair of BKI presented a report and spoke about the work of BKI and the year of renewal. She said the Strategic & Operational Plans are currently being worked on. Ms Law spoke about some of the key issues and challenges facing BKI including financial matters, the site and the building situation. She thanked the Synod in WA for their continuing support of BKI.

Resolution: 27/2022 The Caring Agencies reports were accepted en block by consensus.

MINUTE OF APPRECIATION - AMANDA HUNT CEO UNITINGWA

John Berger presented a minute of appreciation for Amanda Hunt on behalf of the Board of Uniting WA as follows:

The Board of Uniting WA wishes to record its appreciation for the service of Amanda Hunt as CEO of Uniting WA from March 2017 to December 2021.

During her time at the helm, Amanda brought about substantial change to Uniting WA, building the structure and culture needed for a contemporary community sector organisation. Some of the notable achievements under her leadership include:

- Organisational re-structuring and re-focusing of the business
- Re-branding from UnitingCare West to Uniting WA
- The relocation of Uniting WA's head office to be co-located with the services being offered from Aberdeen St, Perth
- The refurbishment of the Tranby Engagement Hub into a respectful and inclusive space for those experiencing homelessness
- Transition to the NDIS and expansion of services offered
- Working closely with the Uniting Church WA in engaging with the National Redress Scheme
- Emphasising the importance of First Nations voice, treaty and truth, including implementation of the Stretch RAP and support for the Uluru Statement.

Amanda provided the space and capability to embed in Uniting a new understanding of the aspirations of First Nations people, their ways of thinking and working, and ensured we have a new respect for them individually and as a whole. She brought a level of credibility to Uniting WA, and by association to the Uniting Church, in her external advocacy.

He has served on numerous advisory and consultative bodies and committees to federal, state, and local governments and on the boards of various non-government organisations. These included the Western Australian Council of Social Service, the WA Human Services Industry Round Table, and as a member of the National and Executive Committees of UnitingCare Australia. The Synod Standing Committee and the General Secretary of the time, often called upon the skills and experience of Chris in a range of advisory roles including a number of selection panels for senior roles across the Synod.

REPORT 36 REVISED STRATEGIC DIRECTIONS FOR THE UNITING CHURCH IN WA (PART 2)

Rev Hannes Halgryn (Associate General Secretary) facilitated feedback from the table discussions received from the previous session of the Revised Strategic Framework. He summarised feedback from the following points:

- The Purpose Although most were in agreement with the Purpose statement adopted from the Constitution Paragraph 4. A few concerns were raised whether it is too broad.
- The Vision Most feedback noted that they found the Vision Statement as simple, meaningful, and easy to relate with. They appreciated that it is only a subtle change_from the previous logo.
- The Values Tables were in agreement that "compassion" be changed to "love" and also appreciated that it was symbolised in graphic form.
- The Focus Areas Appreciation was expressed that the five focus areas aligned with the five marks of mission and therefore also with the work of Thrive. Note: The biblical reference under partnerships was noted as "1 Thessalonians 5:11" and not Genesis 9:16, 17 (NRSV).
- The Objectives Appreciation was expressed for the ability of the Objectives and also that they relate to all the focus areas. Questions were raised on how this would be implemented in Congregations and how Synod will determine the strategic priorities

After some questions from members, it was agreed that the Revised Strategic Directions for the Uniting Church in WA go back to the Synod Standing Committee for some rewording and be presented for approval.

Resolution: 34/2022 The Revised Strategic Directions for the Uniting Church in WA was received and noted. It was noted that the Revised Strategic Directions for the Uniting Church in WA would be reworded and be presented to Synod Standing Committee for approval.
