The Opening Worship was conducted at Floreat Uniting Church, on Thursday evening 10 September 2015 and the business sessions of the 39th Meeting of the Synod and the 10th Annual Meeting of the Presbytery of WA were conducted at Scotch College, Swanbourne on Saturday and Sunday 12-13 September 2014.

JOINT MEETING OF SYNOD AND PRESBYTERY

PART I - CONSTITUTION

1/2015 CONSTITUTION OF THE MEETINGS OF SYNOD AND PRESBYTERY

The combined Synod and Presbytery meetings were constituted by an act of public worship on Thursday evening 10 September at 7.30pm with a congregation of approximately 100. Rev Steve Francis preached on the theme of the Synod, Towards Healing and Wholeness through Faith, HOPE and Love.

PART 2 - OPENING REMARKS

2/2015 MODERATOR'S WELCOME

At the first business session introductions and preliminary comments were made by the moderator, Rev Steve Francis, where he acknowledged the Wadjuk people of the Noongar Nation, their elders past and present and their people. The Moderator also welcomed new members of the Presbytery and Synod.

3/2015 WORSHIP AND BIBLE STUDY

The business session on Saturday morning was opened with song and prayer.

Rev Ruth Vertigan lead devotions on Saturday (morning, afternoon and evening) and Sunday afternoon.

Dr Elaine Ledgerwood lead bible studies on Saturday morning and Sunday Afternoon.

The Eucharist was celebrated on Sunday morning 13 September. The service was led by Rick Morrell and the First Third Specialist Team who shared in the leading of communion.

4/2015 PRESENTATIONS

The following presentations were made over 12-13 September 2015. Some related to the life of the Presbytery, others to the life of the Synod.

First Third Team

Rev Hollis Wilson, Chair of First Third Working Group, acknowledged and thanked Rick Morrell for the work he had done for Synod and Presbytery in the previous two decades. Rick will be transferring to the NSW Synod at the end of October 2015, to take up a position of Director of Mission for UnitingCare NSW/ACT. Rev Brenton Prigge, First Third Specialist and Paul Montague also acknowledged Rick and presented Rick with a gift.

Assembly 2015 Local Organising Committee

Travis Windsor, Convenor, presented a report about the 14th Triennial Assembly of the Uniting Church in Australia which met in Perth from Sunday 12 to Saturday 18 July 2015 with the theme "Hearts on Fire". The Local Organising Committee acknowledged all who were involved in making this event successful.

- I. Plenty of work took place behind the scenes especially during the last two days prior to Assembly when both church office staff and volunteers gave their full dedication.
- Transport arrangements worked well.
- 3. GSI was generous towards the international guests, providing all that was needed (donations of blankets, with emergency accommodation, etc).

- 4. The Installation Service arranged by the Worship Team headed by Rev Cathie Lambert, showcased not only the best of Assembly but also WA to the Assembly members. All their work was greatly appreciated.
- 5. All the volunteer help was tremendous.
- 6. Schools and agencies got involved, especially through the art work on the theme of *Hearts* on *Fire*.
- · 7. Schools provided buses to transport members and guests.
- 8. All the work of Clare Ligtermoet in her role as Events Coordinator, together with staff and resources were greatly appreciated.
- 9. Assembly provided a fantastic opportunity to meet people representing all of Australia's rich diversity and international guests.

Rosemary Hudson Miller added that there were 129 volunteers in all, including some from our schools, agencies, tertiary colleges, who coordinated travel, accommodation, helping with IT and AV systems for all the days of assembly, as well as to provide the beautiful music. It was a very demanding time for all concerned in the lead up and during the Assembly. This Synod proved that we are a wonderful, tiny but dynamic group. Rosemary acknowledged the key role of Travis who constantly displayed good leadership and humour. The Assembly business committee gave wonderful feedback. We are very grateful that we will be having the next Assembly in Melbourne. Staff have nearly taken all their accrued time off in lieu. Travis also coordinated the training and guidance of volunteers together with a wonderful pastoral oversight.

The Moderator expressed his personal thanks to Rosemary, Clare, Travis and all the volunteers and staff. At Assembly, it was evident to see how everyone can come together and do something special in the name of God. The team of people was fantastic, very inspiring and encouraging and the location was perfect. The Moderator thanked everyone who had served us and represented our Synod in such an extraordinary way.

UnitingCare Forum Presentation

Rev John Dunn, Chair of the Forum, introduced the CEOs of our agencies who were present, namely John Knowles from Good Samaritan Industries (GSI) and Vaughan Harding from Juniper. Rev Daniel Viljoen from UnitingCare West (UCW) was also present. It was proposed that these persons be associated for the purpose of this business.

Approved by Consensus.

Some questions were asked about the Juniper Report Pastoral Care Section to which Vaughan Harding responded. He reported that regular services are held in all the homes, coordinated by employees of Juniper who provide pastoral care. In regard to the training of volunteers, Juniper provide their own pastoral training. When the question was posed about whether the trainer is ordained or not, Vaughan was uncertain.

Sue Ash Chief Executive Officer of UCW, (also a member of Synod) noted that UCW's relationships with congregations are evolving. A new service centre has been opened in Fremantle which has been working with the Fremantle congregation for some time. UCW connected with five of the congregations in the area including Daniel Viljoen visiting, preaching and inviting members of the congregations to the new venue. There is a long standing, consistent relationship with the Uniting Church in the City (UCIC). UCW is now actively seeking to work together with congregations. Another focus of UCW's work is the Great

Southern Region. Rev Daniel Viljoen was available throughout the Synod meeting to respond to any queries.

UnitingCare West - "Disadvantage in WA"

CEO Sue Ash presented this topic. Established by the 2005 Synod, UCW has now been in existence for 10 years. Once a year, a survey is done of more than 1000 clients to provide feedback. The UCIC makes the largest contribution of church funds for UCW's work. Sue also gave an outline of UCW's other current work.

Invitation by Social Justice – Symbolic Action on Climate Change

The Social Justice Board invited members to participate in a Symbolic action (weather permitting) for a photo opportunity to make a stand on Climate Change.

Future Synod Meetings Discussion – Table Groups

Members had 25 minutes to discuss the following questions:

- 1. Does your table warm to the idea of less frequent Synod meetings? Why?
- 2. Currently Synod is 2 days with a one day Presbytery. How does your table feel about a three day Synod with two separate 1 day Presbytery meetings in a Synod year?
- 3. Which areas of responsibility do you think could be delegated to Regional Gatherings? What do you think should not be delegated? Why?

 - 1.1 Use negotiated partnership approaches to work with Indigenous peoples in developing a detailed consultation framework and evaluation process concerning the sustainability of remote communities in Western Australia to ensure the free, prior and informed consent of Aboriginal peoples (this includes the right to negotiate and communicate in their language of choice, and through their specified mechanisms).
 - 1.2 Provide genuine reassurance to communities that services will not be withdrawn, unless this outcome is self-chosen and thorough transition support is provided.
 - 1.3 Maintain full transparency and ensure the presence of independent monitors throughout the consultation process.
 - 1.4 Renegotiate funding arrangements with the Federal Government as was done in South Australia.
 - 1.5 Ensure adequate, long-term funding and support through negotiated partnerships with Aboriginal communities for the implementation of their own strategies for development and sustainability.

2. Ask that the Federal Government:

- 2.1 Reinstate funding for essential and municipal services for Aboriginal communities.
- 2.2 Provide oversight to the WA State Government's 'Regional Services Reform' and to all States' ongoing management of Aboriginal communities to ensure adherence to international human rights particularly the right to consultation and consent as expressed in Article 19 of the United Nations Declaration on the Rights of Indigenous Peoples which declares that "States shall consult and cooperate in good faith with the indigenous peoples concerned through their own representative institutions in order to obtain their free, prior and informed consent before adopting and implementing legislative or administrative measures that may affect them."
- 2.3 Ensure adequate, long-term funding and support through negotiated partnerships with Aboriginal communities for the implementation of their own strategies for development and sustainability.

- 3. Authorise the Standing Committee, on advice from the Church Law Committee in consultation with UIACC and General Council:
- i. to make the necessary changes to the By-Laws;
- ii. to transfer such powers and responsibilities as necessary and as requested by Congress to the Synod or other appropriate body. (Constitution Division 8 Paragraph 70)
- iii. report to the May 2016 meeting of Presbytery (Constituting a special meeting of the Synod for this report).
- 4. Authorise the Standing Committee to resolve that the first meeting of the (to be advised) Presbytery, to be held on the (date to be advised) shall be presided over by the Moderator until the election of an inaugural chairperson (Regulation: 3.4.6 (d))

Approved by Consensus

Synod agreed for Robert Watson to step in as Moderator for Steve Francis (Co-Chair covenanting Commission) to present Proposal 4.

22/2015 COVENANTING COMMISSION REPORT TO UAICC WA and PROPOSAL 4

Presented by Rev Steve Francis and Rev Ian Robinson.

It was proposed that the Synod:

- 1. Note the long-held commitment to the Covenant between the Uniting Aboriginal and Islander Christian Congress (UAICC) and the Assembly of the Uniting Church in Australia.
- 2. Commit to a principle of ongoing financial contribution to First Peoples as the traditional owners and custodians, of the land and waters from which we all now benefit.
- 3. Request Resources Board in consultation with UAICC and the Covenanting Commission General Council to establish a Task Group to investigate how the Synod can increase its contribution to UAICC-WA.

- 4. Work with UAICC-WA to provide a clear account of expenditure with an aim to ensure ongoing financial sustainability.
- 5. Request the Resources Board report to the next meeting of the Synod as to how this policy is intended to be implemented, the scope of the final policy, and to identify any barriers which may impede the implementation of this policy.

Approved by Consensus

23/2015 CONGRESS - PROPOSAL 15 - REMOTE AREA MINISTRY

Proposal presented by Rev Neville Campbell. It was proposed that the Synod, when considering future directions and ministry placements in remote areas of Western Australia within the bounds of the WA Synod note the view of the WA Congress that priority be given to the following principles:

- I. Remote Area Ministry with Aboriginal people should focus on cultural and spiritual practices of Aboriginal people and therefore should be strategically located with Tom Price (Pilbara), Burringurrah (Gascoyne and Murchison), Warburton (Desert regions) and Menzies/Leonora (Wongi people)
- 2. Ministry style should focus on developing significant relationships with people over time so that people can be empowered, particularly to become sustainable communities and resist pressures to abandon remote communities. This is much more than a mobile chaplaincy service.
- 3. People working in Remote Area Ministry should have demonstrated capacity to relate with Aboriginal people at the cultural and spiritual level and to be able to communicate and empower people to grow in their own culture within the dominant Western society.
- 4. People in Remote Area Ministry should have the capacity to build bridges between Aboriginal people and non-Aboriginal people
- 5. It is important that people working in Remote Area Ministry and the Church are careful about all relationships and partnerships developed. It can be unhelpful in our relationships with Aboriginal people if we are seen to be too closely allied with mining companies and government agencies that are not always viewed positively by Aboriginal people.
- 6. Involve the WA Congress in its planning, placement processes, review and consultation with both Aboriginal and non-Aboriginal people, and
- 7. Work with the WA Congress and Beananging Kwuurt Institute in training ministry agents and other workers in Remote area Ministry.

Approved by Consensus

24/2015 STRATEGIC DIRECTIONS - PROPOSAL 17

Presented by Rev Ivan Clark. It was proposed that the Synod:

- 1. affirm the primary call of the church as expressed in the Basis of Union "to be a fellowship of reconciliation ... an instrument through which Christ may work and bear witness to Himself" (paragraph 3) and that this is embodied through its "worship, witness and service" (paragraph 15);
- 2. toward this goal to note the strategic directions of the Presbytery of WA:
 - i) developing a culture of open communication,

- ii) promoting a culture of faith formation and faith sharing,

BYLAW 3.17 - Multicultural and Cross-Cultural Ministries Commission

NAME

3.17.1 The name of the Commission is the "Multicultural and Cross-Cultural Ministries Commission", a Commission appointed by and responsible to the Presbytery of Western Australia.

DEFINITION

3.17.2 Multicultural and Cross-Cultural Ministry Team means those persons appointed as Ministers and Associates by the Presbytery to provide a network of support to Multicultural and Cross Cultural Ministries and includes the Multicultural and Cross Cultural Ministry Team Coordinator.

MEMBERSHIP

- 3.17.3 The members of the Commission are appointed by the Presbytery and comprise:
 - a) the Chairperson, elected annually by the Presbytery;
 - b) up to five people each nominated from a recognized multicultural or cross-cultural faith community or congregation served by the Multicultural and Cross-Cultural Ministry Team, elected annually by the Presbytery;
 - c) up to five people nominated from other congregations with appropriate gifts and skills to give effective support to multicultural and cross-cultural ministry and outreach activities; preferably including at least one Minister, up to two people nominated from First Third ministry and up to two people nominated by groups not yet part of the Uniting Church, elected annually by the Presbytery;
 - d) the Multicultural and Cross-Cultural Ministry Team Coordinator;
 - e) The Moderator; and
 - f) The General Secretary or his or her nominee
- 3.17.4 The Commission may co-opt up to three further members, for terms not exceeding twelve months at a time, to ensure balanced representation or to provide the Commission with knowledge, abilities or experience not otherwise available to the Commission.

PURPOSE

- 3.17.5 The purpose of the Commission is to act for the Presbytery to
 - a) support, encourage and assist with the development of multicultural and cross-cultural ministry across the Church;
 - b) assist or advise in resources and training that would assist in worship, witness and service appropriate to multicultural and cross-cultural ministry;
 - c) assist in strengthening links between multicultural and cross-cultural faith communities, congregations and groups and between those groups and the wider church;
 - d) encourage linkages and networks across the Uniting Church so that the special needs of youth, families and older groups in the multicultural and cross-cultural groups, faith

- communities and congregations can be met and new faith communities and congregations established, affirmed and given support;
- e) maintain a directory of multicultural and cross-cultural faith communities, congregations and groups; and
- f) provide support and advice to the Multicultural and Cross-Cultural Ministry Team as appropriate.

RESPONSIBILITIES

- 3.17.6 The responsibilities of the Commission include:
 - a) developing policy, strategies and plans to meet the challenges and issues of the multicultural and cross-cultural Church;
 - b) assisting with the monitoring and evaluation of current and new initiatives in multicultural and cross-cultural ministry;
 - c) working collaboratively with the Multicultural and Cross-Cultural Ministry Team, supporting and encouraging them in their ministries;
 - d) advocating on multicultural and cross-cultural ministry related issues in the Councils and Commissions of the Uniting Church;
 - e) working collaboratively with the other Commissions and staff of the Presbytery to ensure good stewardship of the gifts, resources and skills of the Church;
 - f) encouraging the whole Church to celebrate the achievements of the multicultural and cross-cultural faith communities, congregations and groups and their ministries;
 - g) establish task groups or sub-committees to support, resource or facilitate initiatives or particular groups that would be helpful, which shall report regularly to the Commission; and
 - h) any other matters relating to multicultural or cross-cultural ministry that may arise from time to time.

MEETINGS AND REPORTING

- 3.17.6 The Commission will:
 - a) meet at least four times each year;
 - b) meet or consult using electronic means as required;
 - c) report to the General Council and the Presbytery as requested or when necessary.

3.5.13.3 MINISTRY OF PASTOR WORKING GROUP

(Regulations 2.2.2; 2.3.3; 2.4.3; 2.4.6; 2.6.9; 2.7.4)

NAME

3.5.13.3.1 The name of the Working Group is the "Ministry of Pastor Working Group", a working group responsible to the Presbytery through the Pastoral Relations and Placements Commission.

MEMBERSHIP

- 3.5.13.3.2 Membership of the Minister of Pastor Working Group to include:
 - (a) Chairperson who is elected annually by the Presbytery;
 - (b) Pastoral & Placements Unit Manager or representative from the Pastoral Relations and Placements Commission (PR&PC);
 - (c) A representative from Commission for Education, Discipleship and Leadership (CEDAL);
 - (d) a Human Resource Adviser appointed by the General Secretary;
 - (e) Member of the Candidates for the Ministries Commission (CMC);
 - (f) Up to three other persons.

PURPOSE

- 3.5.13.3.3 The purpose of the Ministry of Pastor Working Group is:
 - (a) co-coordinating and assisting in the implementation and on-going management of the position of Ministry of Pastor within the Uniting Church in Western Australia;
 - (b) providing assessment of whether a person can demonstrate the relevant competencies
 - (c) ensuring the suitability of a person to fill the position;
 - (d) implementing and monitoring the learning agreement of each position of Ministry of Pastor;
 - (e) advising the PR&PC on the suitability of position for the Ministry of Pastor.

RESPONSIBILITIES

3.5.13.3.4 The responsibilities for the "Ministry of Pastor Working Group" follow Regulations 2.2.2, 2.3.3, 2.4.3, 2.4.6, 2.6.9 and 2.7.4.

The functions of the "Ministry of Pastor Working Group" are:

- (a) exercising on behalf of the Synod and/or Presbytery, oversight of the assessment, education and training requirements specific for Ministry of Pastor positions;
- (b) acting for the Synod and or Presbytery in:

- (i) receiving and recommending to the Pastoral Relations and Placements Commission that the position description is suitable for a Ministry of Pastor appointment as per Regulations;
- (ii) following approval of the position description by the Pastoral Relations and Placements Commission ensure Presbytery or Synod participation in the appointment process;
- (iii) assessing whether a person can demonstrate the relevant competencies;
- (iv) overseeing the implementation of a learning agreement;
- (v) on appointment of a person, informing the Pastoral Relations and Placements Commission including any requirements for fulfilling core competencies so that a commissioning of the person as a Pastor can be arranged on completion of requirements;
- (vi) identifying someone to work with the Pastor in determining a program of on-going ministry formation/education and monitoring the progress of such learning agreement;
- (vii) advising the Synod's Ministerial Education Board (MEB) annually of each Pastor's learning agreement and progress;
- (viii) advising the Pastoral Relations and Placements Commission that a position be terminated should the competencies or learning agreement not be fulfilled:
- (ix) promoting the role of Ministry of Pastor.
- (c) undertaking all work according to Confidentiality policy of the Synod in accordance with the Code of Ethics and current civil legislation.

8.3 Uniting Church Homes t/a "Juniper, a Uniting Church Community" Constitution

Name

8.3.1 The name of the instrumentality is "Uniting Church Homes" trading as "Juniper, a Uniting Church community", a body corporate incorporated under the provisions of the Uniting Church in Australia Act 1976 (WA).

Definitions

8.3.2 'Act' means the Uniting Church in Australia Act 1976 (WA) or any subsequent Act or statute that amends or replaces it.

"agency" means any body whether incorporated or unincorporated established by or on behalf of the Church for a religious, educational, charitable, commercial or other purpose.

"By-Law" or "By-Laws" refers to or means the By-Laws of the Synod of Western Australia.

"Board" means the Governance Board established pursuant to clause 0 of this Constitution.

"Church" means the Uniting Church in Australia.

"Constitution" means a document approved by the Synod setting out governance procedures to be observed by an agency of the Church.

"General Council" means the General Council of the Synod of Western Australia and the Presbytery of Western Australia of the Uniting Church in Australia.

"Juniper" means Uniting Church Homes trading as "Juniper - a Uniting Church community".

"member of the Church" means a confirmed member or a member-in-association of the Uniting Church in Australia.

"Moderator" means the Moderator for the time being of the Synod of Western Australia of the Uniting Church in Australia.

"Regulation" or "Regulations" mean or means the Regulations of the Uniting Church in Australia.

"Synod" means the Synod of Western Australia of the Uniting Church in Australia.

"Synod meeting" means an ordinary meeting or a special meeting of the Synod.

"written" and "writing" include communication by post or electronically.

Object

8.3.3 Juniper is a not-for-profit Christian organisation that embraces the ethos and values of the Uniting Church in pursuing its Object of providing accommodation, care and support services to aged people in Western Australia.

In fulfilling this Object Juniper will:

- (a) work in co-operation with the structures of the Uniting Church;
- (b) undertake a significant leadership role in matters pertinent to the Object; and
- (c) engage with relevant industry bodies, governments, other non-government community service agencies, business and media.

Governance Board

8.3.4 The Synod, in accordance with its powers under Regulation 3.5.34 (Regulations 2015, 3.7.4.7), has established Juniper and appointed the Board to have responsibility for the good governance of Juniper.

The Board shall monitor the skills mix of its membership and make recommendations to the Synod for the appointment of new members, and co-opt new members, who have expertise, qualifications or experience in relevant disciplines such that in aggregate the Board shall have an appropriate mix of skills and abilities appropriate to the governance of Juniper, taking account of the provisions of clause 0 below.

All members of the Board must have an awareness, or willingness to acquire a general working knowledge, of the compliance requirements to be met by Juniper and must embrace and support the core values and ethos of the Uniting Church.

Membership

- 5. The Board is appointed by the Synod and consists of:
 - (a) Seven persons for terms of up to three years, and will be eligible for reappointment for a continuous term not exceeding 10 years.
 - (b) At least four of the Synod appointees must be persons who have relevant expertise or qualifications, or experience in the Governance of organisations of similar size and complexity to Juniper.
 - (c) Terms of elected members will be such that, as far as practicable, approximately one third of the elected positions fall vacant each year.
 - (d) The chief executive of Juniper shall be an ex officio member of the Board.
 - (e) No other staff member of Juniper is eligible to be appointed to the Board.
 - (f) A Chairperson shall be appointed by the Board from the Synod appointed members. The chief executive of Juniper may not serve as Chairperson.
 - (g) The Board may co-opt up to two persons who have particular skills and expertise for terms not exceeding two years, and such co-opted members shall be eligible for reappointment.
 - (h) Where practicable 2 Board members should be confirmed members of the Uniting Church and eligible to represent Juniper at the annual meeting of Synod.
 - (i) Subject to all of the above parameters Board members will be selected and appointed primarily on their capacity and willingness to fulfil the governance role.

Vacancies

- 6. A casual vacancy occurs in the membership of the Board if a Synod appointed Board member:
 - (a) dies;
 - (b) resigns by notice delivered to the Chairperson of the Board;
 - i. is convicted of an indictable offence or becomes bankrupt;
 - ii. suffers any mental or physical incapacity which inhibits or prevents the member from continuing to act as a member of the Board;
 - iii. fails to attend three consecutive meetings of the Board without leave or fails to attend at least 50% of the meetings in any calendar year without leave; or

- iv. is removed from office by resolution of the Synod, it being expressly declared that the Synod is not required to state any reason for such resolution.
- (c) In the event of a casual vacancy occurring in the membership of the Board, the Board may appoint a replacement member for the remainder of the term of the member replaced.
- (d) If an ordinary vacancy occurs because the Synod failed to appoint any or all of the members of the Board, then the retiring member or members continue in office.
- (e) The General Council may appoint persons to fill any or all of the ordinary vacancies.

Responsibilities And Functions Of The Board

- 7. The Board is responsible for:
 - (a) the governance of Juniper, including overseeing the management and administration of all real and personal property, including but not limited to the power to buy, sell, lease or let any real or personal property, plant, equipment, consumable item or other asset to be used either at the time or in the future in furtherance of the Object and for this purpose to lend or borrow either with or without security as the Board shall from time to time think fit;
 - (b) appointing, dismissing, setting the duties and managing the performance of the chief executive;
 - (c) ensuring that the Object is promoted, which may include establishing appropriate vision, mission, values, policies and corporate objectives for Juniper;
 - (d) approving business and strategic plans, including budgets;
 - (e) entering into such financial arrangements with Synod as in the opinion of the Board are appropriate to acknowledge the contribution of the wider Church to the attainment of the Object.
 - (f) doing all such other things as are incidental or conducive to furthering the Object and performing these duties.

Moderator is Visitor

8.3.8 The Moderator shall be the official visitor to Juniper, may as such attend and participate in any meeting of the Board, and shall in relation to Juniper fulfil the duties and responsibilities of both the Moderator and the official Visitor as defined in the Regulations of the Uniting Church in Australia.

Delegation

- 8.3.9 The Board may from time to time delegate all or any of its powers or authorities except for this power of delegation, to a committee or the chief executive, and may
 - (a) determine the manner in which a committee or the chief executive shall operate;
 - (b) suspend or withdraw this delegated authority.

Proceedings of the Board

- 10. The Board
 - (a) The Board shall meet at the time and place determined from time to time by its own resolutions but shall meet not less than four times a year;
 - (b) the chairperson may at any time she or he thinks it necessary and shall, whenever requested in writing to do so by not less than three Board members (which writing shall specify the

- purpose for which the meeting is to be convened) convene or authorise the chief executive to convene a special meeting of the Board;.
- (c) at least seven days written notice of every Board meeting shall be given to all members of the Board but if the chairperson considers an emergency exists a special Board meeting may be convened on shorter notice;
- (d) the non-receipt by a Board member of a notice of meeting does not invalidate the meeting;
- (e) the chairperson shall preside at all meetings of the Board but if for any reason the chairperson is absent from a meeting the Board members present at that meeting shall, unless a deputy chairperson has been appointed under sub clause 6 and is present at the meeting, elect one of their number to be acting chairperson during the absence of the chairperson;
- (f) the Board may elect a member of the Board to be deputy chairperson to act as a chairperson of the Board whenever the chairperson is absent or is unable for any reason to carry out the duties or exercise the powers of the office of chairperson;
- (g) all acts done by any meeting of the Board or of a committee of the Board or by any person acting as a Board member are, notwithstanding that it is afterwards discovered that there was some defect in the appointment of a person to be a Board member or a member of the committee, or to act as a Board member or that a person so appointed was disqualified, as valid as if the person had been duly appointed and was qualified to be a Board member or to be a member of the committee.

Quorum

8.3.11 A quorum for a Board meeting is the greater of four or the next whole number above half the current membership of the Board, and the Chairperson may be counted in that number.

Voting

- 8.3.12
- (a) Each Board member has and may exercise one vote and in the case of an equality of votes, the chairperson of that meeting, in addition to a deliberate vote, has a casting vote.
- (b) A member of the Board shall not participate in, vote on, or be present during any debate on any matter before the Board (or any of its committees) in which he or she has an interest.
- (c) Resolutions may be passed outside a meeting of the Board by a majority of Board members agreeing in writing (which writing may include email or other electronic communication) to a resolution, and a resolution so passed shall be deemed to have been passed at a meeting of the Board held on the day on which the last Board member agreed;
- (d) A resolution passed by the Board shall not be rescinded at a subsequent meeting unless seven days' notice of the intention to propose the rescission is given in the notice convening the meeting and unless the rescission is agreed to by two-thirds of the votes cast.

Expenses

8.3.13 The Board members may be paid all travelling and other expenses properly incurred by them in attending and returning from meetings or otherwise in connection with the business of Juniper.

Minutes

8.3.14 The chief executive shall cause to be kept a record copy of the minutes of all meetings of the Board and the minutes shall be confirmed by the next succeeding meeting of the Board.

Chief Executive

- 8.3.15 The Board shall appoint a chief executive on such terms and conditions as it shall think fit who is preferably a confirmed member of the Church or a confirmed member of another Christian denomination but who in any event is willing to participate in the life of the Church.
 - (a) The chief executive's appointment is terminable at any time by the Board in the event of the serious illness or incapacity of the chief executive or for good cause and in accordance with any service agreement between the Board and the chief executive;
 - (b) no termination by the Board is effective unless notice of the motion of termination is given in the notice convening the meeting at which it is intended to move the motion; and
 - (c) the chief executive shall:
 - (i) be responsible for managing Juniper under guidelines established by the Board from time to time which will be sufficient to provide effective operational oversight of care delivery, financial integrity and development of new services;
 - (ii) be responsible for carrying out the policies and directions of the Board;
 - (iii) have under general control of the Board responsibility for the selection, appointment, setting of duties and termination of all other staff;
 - (iv) be accountable to the Board for all matters relating to the good management of Juniper;
 - (v) formulate annually for the approval of the Board, and monitor continually, strategic and business plans;
 - (vi) be secretary to the Board; and
 - (vii) carry out such other functions and duties as are requested by the Board.

Conformity with the law of the Church

8.3.16 In managing the business and affairs of Juniper, the Board shall conform to the law of the Church provided that with respect to any dealings with any of the real or personal property of the Board no person or corporation being a vendor, purchaser, borrower, lender, lessor, lessee or otherwise dealing with the Board shall be concerned to see the observance of the provisions of this paragraph or to be affected by notice of non-observance thereof.

Property

8.3.17 The real and personal property of Juniper is vested in Juniper.

Annual Reports and Accounts

- 18. Juniper shall
 - (a) keep such accounting records as correctly record and explain the transactions of Juniper (including any transactions as trustee) and the financial position of Juniper; and
 - (b) keep its accounting records in such a manner as will enable the preparation from time to time of true and fair accounts of Juniper;
 - (c) Juniper shall keep the accounting records at such place or places as the Board thinks fit;
 - (d) the accounts are to be prepared in such form and at such times as the Board determines;
 - (e) the accounts are to provide at the least a balance sheet and profit and loss account;

- (f) Juniper shall prepare and attach to the annual accounts a report indicating the overall achievement of objectives of Juniper during the year reported by the accounts;
- (g) Juniper shall report annually to Synod in a form prescribed by Synod and containing the audited accounts of Juniper

Audit

19.

- (a) The annual accounts of Juniper are to be audited by a registered company auditor who shall be appointed by the Board.
- (b) The term of appointment of the auditor shall be for the period until the close of the next Juniper financial year but if no change is indicated by the Board at least one month prior to the issue of the auditor's report on any set of annual accounts that auditor shall be deemed reappointed for the next financial year.
- (c) The powers and duties of auditors as to reports on accounts shall be similar to those contained in s.332 of the Corporations Law.

Indemnity

8.3.20 All Board members and officers of Juniper shall be indemnified consistent with Clause 4.11.2 of the Uniting Church In Australia Regulations, and Board members shall be offered a Deed of Access, Insurance and Indemnity in a form approved by the Board.

Dissolution

8.3.21 In the event of the dissolution of Juniper, the Deputy Commissioner of Taxation shall be notified in writing of the date of such dissolution. Any surplus monies or other property held beneficially by Juniper at that time shall be paid to another instrumentality of the Church that has been recognised by the Deputy Commissioner of Taxation as a Public Benevolent Institution under Section 78(i) or (ii) of the Income Tax Assessment Act 1936 as amended.

Amendment of the Constitution

22.

- (a) This Constitution may only be amended in accordance with the By-Laws.
- (b) This Constitution may only be repealed in accordance with the By-Laws.
- (c) The Board may submit a request to the Synod for the amendment of this Constitution.
- (d) Any amendment to this Constitution will be advised to the ACNC.
