Minutes of the Annual General Meeting of
the Presbytery of Western Australia
The Billabong Uniting Church
on 19 June 2021

1. CONSTITUTION

On Saturday 19 June 2021 at 9.00 am, the Presbytery of Western Australia met at The Billabong Uniting Church, the Chairperson, Bob Hunt, presiding.

There were 106 ministerial and lay members present, with 2 attending via Zoom. 22 apologies were submitted.

2. WELCOME AND ACKNOWLEDGEMENT OF THE TRADITIONAL OWNERS

The Chairperson welcomed the members to this Annual General Meeting.

He paid respect to traditional owners of the land on which we met who have cared for the land since time immemorial, and respect to the Elders of the Noongar nation, past, present and emerging.

Bob gave a summary of the reports, and some general arrangements for the meeting. We would also like to record our particular thanks for Rev Luke Williams who assisted with the technical side of the meeting, and the number of helpers from the Presbytery who assisted in a variety of ways.

3. MEETING ARRANGEMENTS

The Secretary, Revd Dr David Ferguson, reported on the arrangements made for the meeting. He noted particularly that we are meeting in accordance with a COVID Safe plan approved by Church Council of The Billabong Uniting Church and thanked them for their co-operation in making it possible for the Presbytery to meet in their premises.

2. Appoint Rev Margaret Beach and Rev Hollis Wilson as Chaplains for this meeting of the Presbytery.
3. Appoint Rev Ken Devereux and Steve Higgins as scrutineers for this meeting of the Presbytery.
4. Authorise the Presbytery Standing Committee to confirm the minutes of this meeting of the Presbytery.
5. Authorise the Presbytery Standing Committee to act on all matters that are the responsibility of the Presbytery including those excluded items in Presbytery Rule 3.1.2 if a public health warning in relation to the COVID-19 pandemic leads to the cancellation of any future meeting of the Presbytery.

4. OPENING WORSHIP

Rev Luke Williams, the Minister of the Billabong Uniting Church led us in opening worship. He reflected upon 1 Corinthians 1:18-21, reflecting on the way in which this letter was a response to maintaining right thinking about the Gospel in the light of a culture which was often counter to that. He encouraged the meeting to be a place of discernment, and brought messages of encouragement and love from the Billabong Congregation.

5. INFORMATION SESSION - MEETING ARRANGEMENTS

The Secretary informed the meeting of the notion that the Manual for Meetings encourages us to be mindful of the different aspects of our life as a gathered community, and to have specific models of operating for each. He informed the Presbytery that we are trying something new here, and will be seeking feedback at the end of the meeting.

6. ACCEPTANCE OF AGENDA

The Secretary moved, and it was seconded that :

1. That the WA Presbytery agrees to adopt the Order of Business

This was approved by consensus

7. PRESBYTERY STANDING COMMITTEE REPORT

The past Chairperson, Rev Lorraine Stokes, presiding.

This report was received by presentation by Bob Hunt, the Presbytery Chairperson, who highlighted the sheer number of people who contribute to the life of our Presbytery, and thanked us all for our contributions.

8. TREASURER'S REPORT

This report was received by presentation by Marilyn Price, the Presbytery Treasurer, who highlighted that we have received generous contributions from congregations, which with discipline in spending and the Jobkeeper allowance means that the expected loss for this year has been covered in the four months to date.

9. PASTORAL RELATIONS COMMITTEE REPORT

This report was received by presentation by Rev Mark Illingworth, Chairperson of the Pastoral Relations Committee, and Allan Jeffrey, Presbytery Minister – Pastoral who highlighted the contribution of the staff towards the work of the committee.

The Chairperson acknowledged that this meeting is Mark's last act as the Chair of this committee, and thanked him for his diligent and caring service in the role.

10. EXTRA INFORMATION REGARDING PROPOSAL 3

Rev Mark Illingworth provided further information to the Presbytery regarding Proposal 3.

11. THRIVE MISSION COMMITTEE REPORT

This report was received by presentation by Rev Greg Ross, Chairperson of the Thrive Mission Committee, who highlighted that there will be secondary learning hubs for the Mission Shaped Ministry course, and provided information regarding the upcoming National Church Life Survey, encouraging all congregations to participate and offering financial assistance to those who need it to meet the costs of this important source of information.

12. CEDAL (Commission for Education for Discipleship and Leadership) REPORT

This report was received by presentation by Rev David Kriel, Chairperson of CEDAL, who highlighted that from the 1st of July will have 8 Candidates in training for ordained ministry. This puts a lot of pressure on our staff and Presbytery resources (including volunteers) we particularly need people to assist to serve on formation panels.

13. CANDIDATES FOR MINISTRY COMMITTEE

This report was received by presentation by Rev Bev Fabb, Chairperson of the Candidates for Ministry Committee, who highlighted the question of how we can promote a culture of call in the life of the church.

14. INTERGENERATIONAL MINISTRY NETWORK

This report was received by presentation by Janine McDonald, Uniting Generations Co-ordinator, who highlighted the roundtable led by the President of Assembly, and some of the issues that the young people reflected upon:

- The thing I value most about the Uniting Church is ...
- My best experience of the Uniting Church is ...
- The biggest challenge facing the Uniting Church is ...
- I wish that the Uniting Church ...
- How do we want the Uniting Church to engage in the public space?

15. MULTICULTURAL NETWORK

This report was received by presentation by Rev Bev Fabb, Convenor of the Multicultural Network, who highlighted the issue of how we can appoint and recognize the pastoral leaders of congregations even if this is not in a paid relationship.

16. RURAL MINISTRY REPORT

This report was received by presentation by Rev Dr David Ferguson, Presbytery Officer, who highlighted the need to form a working group.

David was invited to elaborate on his trip to areas affected by TC Seroja. An article on this has been published in Revive.

17. NOMINATIONS FOR COMMITTEES REPORT

Rev Claire Pickering, Chair of the Presbytery Chairperson Nominating Group informed the Presbytery of the process to bring the names of Rev David de Kock and Alison Xamon as candidates for that role.

David Ferguson informed the Presbytery of the nominations received for the remainder of our committees.

18. REPORT ON FEEDBACK FROM “WORKING TOGETHER”

Michelle Bunn and David Ferguson presented the results from the feedback from “Working Together”. They highlighted the sense of disconnect felt between the Presbytery and our Congregations, and some of the significant issues underlining these. They reminded the council of the need for us to see our work as the work of a community and indicated that this should be seen as the continuation of a process of discussion and discernment rather than a conclusion.

19. TABLE GROUP SHARING

Table groups were invited to share around the following questions:

- What arose from the reports that we need to discuss further or consider?
- What do congregations need from the Presbytery?
- What can we do about it?
- Presbyteries are called to: *exhort their congregations to fulfil their high calling in Christ Jesus*. What are the key characteristics congregations show when they are doing this?

20. PLENARY SESSION

Table groups were asked to identify the primary issue that arose in their discussions.

The following were identified:

- Asking for a volunteer to read reports before distribution to ensure that they are more accessible to members (for instance explanations of acronyms and use of full names)
- Raising the issue of considering the workload and resourcing of the PRC – working group invited
- We need practical solutions to the issue regarding the recognition of voluntary leaders in multicultural and other congregations without a Minister (Proposal to be presented)
- Building closer, intentional loving and supporting relationships between metropolitan and rural congregations
- What oversight does the Presbytery offer to congregations without a Ministry Agent?
- Have a person appointed to actively contact congregations without a Ministry Agent
- Congregations need to be more valued and supported – suggest a review into the structure and resourcing of the PRC
- How do we broaden our work to include better support and assistance to Synod/Assembly mission activities and workers in our midst (particularly our Bush Chaplains) and also build better linkages with Synod/Assembly networks and agencies?
- We should develop a simple resource to describe the work of the different councils of the UCA

21. INFORMATION ON STRATEGIC PLANNING PROCESS

23. SUMMARY OF RESPONSES

As the ballots were distributed and collected, the Secretary indicated that he had perused the feedback forms from the discussions and that he was of the opinion that the major issues had been covered and that the remainder should be collated and given to the Presbytery Standing Committee and to the Presbytery to assist in further discernment.

Two proposals were indicated to have arisen from the discussion, and these were referred to the decision-making session.

24. ANNOUNCEMENT OF BALLOTS

The Chairperson announced the following ballot results:

The Chairperson then announced the result for the incoming Chairperson of Presbytery, Alison Xamon. He thanked all of those who were willing to offer their services to our life as a Presbytery and requested the Secretary to lead the Presbytery in prayer.

26. PRIORITISATION OF BUSINESS

As we moved into the decision-making phase of our meeting, the Secretary informed the Presbytery of the matters that remained before them, and recommended that the Proposal 4 be addressed, then to move to two proposals that had been developed in the life of the meeting before returning to Proposal 3 and the ballot for the membership of the PRC. This was accepted.

27. PROPOSAL 4 – CLOSURE OF NANNUP UCA

Rev Alan Jeffrey moved and Rev Mark Illingworth seconded:

That the WA Presbytery agree:

- 1 that the Nannup Congregation be dissolved under Reg 3.4.3. by because they can no longer fulfil the purpose, functions and responsibilities required of a congregation under Reg. 3.1.1.
2. to give thanks with deep gratitude for the faithful worship, mission and service of the people of the Nannup Congregation.
3. the Presbytery be authorised to approve details as per Reg 3.4.3 (d)
 - (i) that each member and adherent of the Congregation is transferred to a roll of another Congregation.
 - (ii) that all rolls and other records of the Congregation are placed in the custody of an appropriate officer of the Church; and
 - (iii) that in each case proper arrangements are made to deal with any property affected.
 - (iv) That the matter is referred to the Synod of WA

This was approved by consensus.

28. PROPOSAL 5 – VOLUNTARY PASTORS

Rev Dr Ian Tozer moved and Robert Watson seconded a motion arising from the discussion regarding the appointment of voluntary pastors. After receiving advice from the past General Secretary and some discussion, it was decided that further work should occur on this to incorporate thoughts from the floor.

29. PROPOSAL 6 – INTENTIONAL CONNECTIONS

Pastor John Tomkins moved and Bob French seconded a motion arising from the discussion regarding the support of congregations without a Ministry Agent. After discussion and amendments from the floor, the following was agreed to by consensus:

That the WA Presbytery agree:

1. That Presbytery Standing Committee write to its Congregations and faith communities to ask them to consider whether their congregation or faith community is called to explore intentional relationships for mutual support with another UC Congregation or worshipping community.

30. PROPOSAL 5 – Ctd

Rev Dr Ian Tozer moved and Robert Watson seconded the revised motion arising from the discussion regarding the appointment of voluntary pastors. This was approved by consensus:

That the WA Presbytery agree:

1. That the Presbytery Standing Committee prepare and submit a proposal to the Annual Synod Meeting 2021 aimed at approving formal recognition of unremunerated Pastors in CALD congregations and faith communities within the Presbytery of WA.
2. That the learning from this work help to inform how other unremunerated Pastors can be recognised.

31. PROPOSAL 3- EXTENSION OF THE PLACEMENT OF TOBY KEVA

,
Rev Alan Jeffrey proposed and Rev Mark Illingworth seconded:

That the WA Presbytery agree that:

1. the Placement of Rev Toby Keva be extended from 1 January 2022 for a period of 2 years.
2. commend Rev Toby Keva, the Rockingham Congregation, and Church Council for their ministry; and
3. Thank the consultation team Rev Marie Wilson and Sandy Scott for their work.

After some discussion regarding the factors that members are required to take into consideration when making such votes and a recap of the discernment process that led to the recommendation being made by the PRC, this was referred to a secret ballot as required by Regulation 2.6.8.

32 DISTRIBUTION AND COLLECTION OF BALLOTS

The ballots for Proposal 3, plus that for the members of the PRC were distributed and collected.

33 MIKE MINUTES

The following Mike Minutes were shared:

- Rev Greg Ross (St Augustine's, Bunbury) introduced Rev Willem Smit, a visitor to the Presbytery, who has come from South Africa and has commenced work as a prison chaplain
- Rev Dr Christine Sorensen (CEDAL) promoted the School of Ministry on the theme of "Courage" to be held at Mount Pleasant Uniting Church from 28 June to 1 July
- Doug Birkinshaw (Mandurah) promoted the work of the National Lay Preacher's Association and particularly their conference to be held from 10 to 13 September
- Rev Dr Anne Wright promoted the upcoming intensive on Professional Supervision and reminded Ministry Agents for their responsibility in this area.
- Reuben Edwards (Candidate, Zoom) greeted us from Melbourne and asked particularly for prayers for the Assembly being prepared with significant uncertainties regarding COVID
- Ps Dr Elaine Ledgerwood informed the Presbytery of the Lay Leaders gatherings that she will be holding on the second Saturday of each month
- Rev Marie Wilson invited members to attend the Council of Churches WA AGM to be held at Floreat Uniting Church the next day
- Rev Dr Christine Sorensen informed the Presbytery that an initial run of an Elder/Church Council training program is currently underway, and that it will be made more broadly available in time.
- Evan Maltby (Mundijong) thanked the Davids (De Kock and Ferguson) for visiting their congregation, and remarked upon the shirt bearing the UCA logo that the Secretary was wearing

34. DECLARATION OF BALLOTS

The results of the ballots were declared with Rev Dr Sonny Rajamoney and Sue Strutt appointed as members of the Pastoral Relations Committee

Proposal 3 was declared to be passed:

That the WA Presbytery agree that:

1. the Placement of Rev Toby Keva be extended from 1 January 2022 for a period of 2 years.
2. commend Rev Toby Keva, the Rockingham Congregation, and Church Council for their ministry; and
3. Thank the consultation team Rev Marie Wilson and Sandy Scott for their work.

Toby thanked the meeting for their support.

35. INDUCTION OF PRESBYTERY CHAIRPERSON AND COMMITTEE CONVENORS AND CHAIRPERSONS

The incoming Chairperson, Alison Xamon, was commissioned in worship by Bob Hunt. Alison then led the commissioning of the committee convenors and chairs of the committees.

36. FINAL THANKS

The outgoing Chairperson, Bob Hunt, again took an opportunity to thank all of those who have contributed to the life of the Presbytery during his term.

The Presbytery Secretary then thanked Bob on behalf of the Presbytery for his diligent, passionate and dedicated service to our Presbytery. This was received by acclamation.
