Minutes of the Annual General Meeting of the Presbytery of Western Australia Mount Pleasant Uniting Church on 18 June 2022

1. Constitution

On Saturday 18 June 2022 at 9.00 am, the Presbytery of Western Australia met at Mount Pleasant Uniting Church, the Chairperson, Alison Xamon, presiding.

There were 32 ministerial and 49 lay members present, with 11 attending via Zoom. 25 apologies were submitted.

2. Welcome and acknowledgement of the Traditional Owners.

The Chairperson, Alison Xamon, welcomed the members to this Annual General Meeting, opening in prayer.

She paid respect to traditional owners of the land on which we meet who have cared for the land since time immemorial, and respect to the Elders of the Noongar nation, past and present, recognising the emerging leaders and the ongoing work of our covenant.

3. Meeting arrangements

The Secretary, Rev Dr David Ferguson, reported on the arrangements made for the meeting.

Rev Dr David Ferguson moved, it was seconded and agreed by consensus:

- 2. That the WA Presbytery agrees to adopt the Order of Business
- 3. Appoint Rev Hannes Halgryn and Rev Sophia Lizares as Chaplains for this meeting of the Presbytery.
- 4. Appoint Mary Riley and Steve Higgins as scrutineers for this meeting of the Presbytery.
- 5. Authorise the Presbytery Standing Committee to confirm the minutes of this meeting of the Presbytery.
- 6. Authorise the Presbytery Standing Committee to act on all matters that are the responsibility of the Presbytery including those excluded items in Presbytery Rule 3.1.2 if a public health warning in relation to the COVID-19 pandemic leads to the cancellation of any future meeting of the Presbytery.

This was adopted by consensus

4. Opening worship

A service of worship celebrating the life of the Presbytery was led by the Chairperson, Alison Xamon, and Rev Andrew Broadbent. Andrew preached on Ephesians 2:11-12 and Ephesians 4:1-6, expounding on the theme "Bear with one another in love." He spoke on the human tendency to build walls to divide "us" from "them". He reflected on Jesus, who was one who broke down the barriers of hostility between peoples. He spoke on our need to reach out to God to break down any hostilities that have built up between us and other disciples, so that we can build the bridges of love within our life, within our communities and so that we can make disciples. He challenged us to draw the line between acceptance and agreement, to live and respect one another despite our differences so that we may effectively participate in the mission of God.

5. Chairperson's report

The past chairperson, Bob Hunt, took the chair.

Alison reflected on the disruption of the work of the Presbytery due to illness, and our ongoing need to support each other in such times.

Rev Bev Fabb spoke to acknowledge the huge amount of work that Alison does to support the work of the Presbytery, this was supported by acclamation. Alison acknowledged the support that she receives from the team. The report was received.

The chairperson, Alison Xamon, resumed the chair.

6. PRC report

Rev Ivan Clark spoke to the report, reflecting that his reference to the Presbytery Chairperson as "the wobbly chair" was not meant as a matter of disrespect but rather a comment on her health issues.

He spoke on the hope that we see in one of the congregations that was struggling to recruit a Minister having a name coming to them tomorrow.

He also spoke on the joys of having inherited a committee with no major issues facing it at this stage.

Rev Ian Tozer requested clarification on the status of the PRC documents presented surrounding extensions of Placements. This was clarified as being for information and discussion at this stage.

7. Treasurer's report

Ps Marilyn Price presented the Treasurer's report, highlighting that we have significant positive variations due to staffing vacancies.

The report was received.

8. Thrive report

Rev Greg Ross presented this report on behalf of the Thrive Mission Committee.

Greg responded to a question from Bob Hunt regarding the progress of the 25-year strategic plan process. This was delayed due to COVID among the membership.

He also highlighted the new information that is becoming available through the National Church Life Survey results, and the national census. He highlighted that one of the largest groups regularly attending worship are between 18-34, the lowest is 60-64. He spoke on our need to continue to connect to young people.

Reuben Edmonds noted that Star Street Uniting Church has changed its name, and that this should be reflected in our reports

Carolyn Ebell-Taylor noted that one young member of her discipleship group is actually looking forward to being old enough to join us at Presbytery.

The report was received.

9. Multicultural Network report

Rev Katalina Tahaafe-Williams presented a report on behalf of the network

Rev Ivan Clark (PRC) requested an update of the status of our relationship with the Zimbabwean Methodist Church and the Korean Baptist Church (sharing property with Ross Memorial). Katalina spoke on her preference that multicultural congregations find a common identity with existing congregations, and asked Rev Bev Fabb to provide further information on the specifics. Bev informed the meeting that these groups are part of the network, as they have a practice of being available for groups that wish to better connect with the Uniting Church. Bev informed the committee that the Korean Methodist congregation has been worshipping at Ross Memorial for 15 years.

Rev Marvyn Anderson spoke of some itinerant workers who are now connected with the Uniting Church in Waroona at 7:30 every Sunday morning so that they can go to work afterward.

Annette Bryant spoke on the relationship between Star Street and the Zimbabwean Methodist Church, they would have loved to work with them further, but they could no longer be accommodated due to the size of the building.

The report was received.

10. Information session - Nominations for elections

Sue Whitworth spoke on the process for ballots.

11. Ballot 1 - Election of Committee Chairs

The ballots for committee chairs were distributed and counted, with the Returning Officer announcing that the following appointments had been endorsed by the meeting:

- Rev Ivan Clark (Chairperson of the Pastoral Relations Committee, 1 year)
- Rev Greg Ross (Chairperson of the Thrive Mission Committee, 3 years)

The Chairperson declared them appointed, and thanked them for offering their services

12. UnitingGenerations Network report

Ps Julie Ridden presented on behalf of the network and also Rev Kim Francis (Convenor). She observed several disruptive events in the life of the network: the departure of a valued worker, her own transition into candidacy, and COVID have all been disruptive. The network will continue to try to arrange events to draw youth together. Julie encouraged congregations organising events to connect with the Networks in order that we could promote them. She also requested congregations to get in touch with the network to allow a better flow of information.

The report was received.

13. Rural Network report

Rev Dr David Ferguson presented this report in the absence of a Convenor.

He thanked Rev Gordon Scantlebury for his work in preparing rural ministry resources, which he has been doing on a voluntary basis and will cease in November. While some funds are available to provide this work, no interest has been shown until the morning of the meeting. Funding was confirmed by the Treasurer, Ps Marilyn Price.

Kalo Fotu asked a question regarding the support that the rural ministry team is providing for seasonal workers. Rev Dr Katalina Tahaafe-Williams observed that this is a matter for the multicultural ministry network due to the role they play in linking with appropriate communities, and David observed that financial support has previously been made available for this work by the rural network.

Rev Lorraine Stokes observed that these resources are made available for any community without a minister, not exclusively rural congregations.

The report was received.

14. Joint Working Group on Property report

Bob Hunt spoke on process of identifying properties not connected to congregations, Presbytery has been asked for information regarding them.

Alison McCubbin remarked on the need for good stewardship, and the importance of the work of this group in assisting to meet the challenge of redress. She warned of further hard decisions that will need to be made.

The report was received.

15. Commission for Education for Discipleship and Leadership (CEDAL) report

The Chairperson of CEDAL, Rev Clare Pickering, responded to two questions received.

Firstly, she informed the Assembly Consultation on the work of Perth Theological Hall has been completed. Currently, CEDAL has a draft report with commendations and recommendations for improvement. The committee now has a chance to respond before this goes to the Assembly Standing Committee for ratification. It is after that report has been formally received that further details can be provided to our November meeting.

She also responded to a query regarding advertising of events – this is primarily done through the SEEDS newsletter, you can subscribe to this by contacting CEDAL by email, or via the Facebook page. No central calendar of events has been collected.

The report was accepted

16. Candidates for Ministries Committee report

This report was received by presentation by Rev Bev Fabb, who informed the meeting that

35 people attended the Ministry Expo this year. CMC has released a revised version of their publication "Called by Name" which has been prepared with the assistance of the Synod Marketing and Communications team. All members will be provided with a copy under two conditions: they commit to reading it, and to pray for someone from your congregation who you should be passing this on to with appropriate encouragement.

Rev Mervyn Anderson thanked those who supported Rev Mitchell Garlett through to his ordination, this was an incredible event within the life of the Church and his community. He encouraged Presbytery members to continue to support Mitchell.

Steve Francis spoke of the sign of hope that the CMC is for the life of our Church. He commended the inspirational work of this group. Supported by acclamation.

The report was accepted.

17. Table group discussion

Table groups were invited to consider the following questions:

- What arose from the reports that we need to discuss further or consider?
- What do congregations need from the Presbytery?
- What can we do about it?
- Presbyteries are called to exhort their congregations to : fulfil their high calling in Christ Jesus. What are the key characteristics congregations show when they are doing this?

16. Plenary session

Table groups were invited to report on the key issues that arose in their conversations. These were:

- Outreach to migrant workers where are they and how many of them 15 country towns identified. Develop a program of fellowship and support for these people building relationships, asking what they need, and supporting them in their faith journey.
 E.g. visits, contacting local congregations to encourage them to build links.
- The complexities around connecting with migrant workers was noted. We need to develop a number of projects around this area and the need to connect with available resources.
- Concerns around the Synod/Presbytery Property Strategy total redress amount is unknown, but the process is 6 years. We need to encourage our congregations to consider what they want their legacy to be. Need to equip retired ministers to communicate information regarding Synod and Presbytery matters to congregations without ministers.
- Concern around the failure to fill the UnitingGenerations position. The ongoing funding model for the Presbytery (in relationship to the Synod) is unclear. We cannot plan for staffing positions without some clarity in this area.
- We need that we need to have an opportunity in our meeting for hearing stories of hope.
 We need to grow a culture of hope.
- We need to hear the concerns of small congregations that can't afford a minister. Hard to find people to come in and help them, particularly around training needs and responses to opportunities such as baptisms. Need for intentional work from the Presbytery officers.
- What does it mean that young people are going to church, but not being represented in

- our congregations?
- Having more communication from the Presbytery. One opportunity to help is for time to be taken to reflect with our congregations on what is happening in the life of the Presbytery.
- Open flexibility required in our relationships with multicultural congregations need to build around hospitality and cultural sharing.
- Need to help our smaller congregations, not just with resources, but also with more connections and information about what is going on in the broader church.
- Intergenerational ministry needs a better focus, hard to maintain a core group within a congregation, the better the opportunities to share the better to support them.
- Suggest more flexibilities in worship times.
- A level of anxiety around redress and property when people don't have enough information, more clarity about the process that will happen. Need the discussion around this to move forward from survival to thriving. In the Zoom group were two regions where other churches were closing, and the Uniting Church was possibly going to be the last in town.
- Need to improve the consistency of our reports.
- Difficulties in getting volunteers effecting the life of our Presbytery and Synod big issue being addressed on an Assembly level.
- How do we embrace change with enthusiasm? Need to lead as a community, if we can't be open, how do we expect our congregations to be?
- Ministers need to participate in continuing education, and congregations need to encourage them to do so. We also need to acknowledge lay presiders at the sacraments better. Help for lay people in conducting events such as funerals. How do our congregations better connect with CEDAL to let them know their needs.
- We have members in association. Is it possible for us to have congregations in association?
- Appreciation for attention being paid to the resourcing for rural ministry.
- A request that congregations be consulted when timing moving Ministers from Placement.

This was referred to the Presbytery Standing Committee, and people who wish to assist in any of these areas are invited to nominate themselves. The groups were also invited to submit any written notes to be transcribed and included as an appendix to these minutes.

17. Ballot 2 – Appointment of Committee Members

The ballot for committee positions opened, the ballots were distributed and collected.

18. Information Session – Moderator Selection Panel

Rev Steve Francis informed the Presbytery of the work of the Moderatorial Selection Panel, helping the community to articulate the criteria they are looking for – and inviting them to active, prayerful participation in the work of discernment that lies ahead of us as we seek a new Moderator.

19. Information Session – ACNC and international donations

Geoff Bice (Executive Officer, Social Justice) presented a presentation informing the Presbytery of the limitations placed upon us by the Australian Charities and Not-for-profits Commission (ACNC). We are obliged to ensure that donations we send overseas meet a set

of standards set by the ACNC. This is difficult as we work with external organisations working within other cultures. He gave examples citing the high expectations required in of two of the 17 sets of criteria we are expected to meet. While UnitingWorld has put this in place with their partners, and we have done this with some of our key partners, this is a process that cannot be offered for large numbers of small partnerships. While we are seeking assistance from other bodies in getting some clarification on how we can maintain these important mission partnerships, significant risks are posed to the Church if we continue in the short term. He encouraged congregations to seek to work with charities that are registered in Australia.

20. Announcement of ballots

20. Proposal 2: Presbytery Liaison People

Rev Ivan Clark brought a proposal regarding the appointment of Presbytery Liaison People from the Pastoral Relations Committee

The PRC were asked to seek further clarity on the purpose of the Regulation, what our possibilities are, and to bring back a proposal to the November meeting.

19. Proposal 3: Additional appointments

Rev Dr David Ferguson presented the following on behalf of the Business Committee, which was adjusted after a discussion which included expressions of concern regarding the current vacancies on the Pastoral Relations Committee and the relationship between the work of this committee and the Placements Committee.

It was observed that the composition of the Placements Committee is a responsibility of the Synod, and that there are reasons why the Pastoral Relations Committee prefers the current relationship structure, but also that this is to be incorporated into the current review of our Rules regarding the Pastoral Relations Committee. It was also observed that the PRC has the authority to co-opt a further two members.

That the WA Presbytery agrees:

20. Proposal 4: Extensions of Placements beyond 10 years

A proposal regarding the process initiated by the Pastoral Relations Committee was brought by Rev Luke Williams and Rev Greg Ross.

While the proposal did not receive consensus, there was consensus that the additional paper attached to the proposal be forwarded alongside the discussion paper.

A revised proposal was generated by discussion and approval of the meeting.

That the Presbytery:

- Request the Pastoral Relations Committee (PRC) to revise the "Discussion Paper on Extensions of Ministry beyond 10 years", in consultation with members of CEDAL, Thrive and others as appropriate to include a broader range of perspectives, based on relevant research, which will enable congregations and church councils to discuss the matter of ministerial extensions with the view to becoming a Church thriving in mission.
- Request the PRC to distribute resources with the view to collecting feedback/input from congregations and church councils and other committees of the Presbytery for discussion at the November Presbytery meeting.
