# Uniting Church in Australia Presbytery of Western Australia



Minutes of
the Ordinary Meeting of
the Presbytery of Western Australia
held at Tranby College, Baldivis
on 9 November 2019

## 1. CONSTITUTION

On Saturday 9 November 2019 at 9.00 am, the Presbytery of Western Australia met at Tranby College, Baldivis, the Chairperson, Bob Hunt, presiding.

There were 72 ministerial and lay members present of whom 5 attended via Zoom video link. 51 apologies were submitted.

## 2. ACKNOWLEDGEMENT OF THE TRADITIONAL OWNERS

As part of the opening worship, Revd Alan Jeffrey paid respect to those whose have cared for this land since time immemorial and to the elders of the Noongar nation, past, present and emerging.

## 3. OPENING WORSHIP

Opening Worship was led by the Revd Alan Jeffrey with music assistance from Rockingham congregation.

Revd Marie Wilson reading from Hebrews 11 (the great cloud of witnesses) and Mark 8 (Jesus calls on the disciples to take up their cross and follow him).

Alan reminded us of the crowd of witnesses who surround us and cheer us on! They kept the faith amid suffering and inspire us. Today, we are the witnesses inspiring each other and bearing one another's burdens. And up in the stands is Jesus, calling us to follow him in his way, bearing his cross.

We sang Elizabeth Smith's Hymn: "God gives us future".

## 4. MEETING ARRANGEMENTS

The Acting Secretary, Revd Des Cousins reported on the arrangements made for the meeting.

Resolved that the Presbytery:

- 1. Adopt the Order of Business for the meeting
- 2. Add to the roll of the Presbytery:
  - (a) Revd Margaret Beach, a priest of the Anglican Church in the Diocese of Perth, inducted on 1 October 2019 as Minister of the St Peter and Emmaus Congregation. (Reg 3.3.4(b)(i))
  - (b) Revd Des Cousins, a retired Minister of the Word, appointed by the Presbytery on 3 August 2019 as Acting Secretary of the Presbytery. (Reg 3.3.4(a))
- 3. Appoint Doug Burtenshaw and Alison McCubbin as Scrutineers for this meeting.
- 4. Appoint Revd Marie Wilson and Revd John Marshall as Chaplains for this meeting
- 5. Authorise the Presbytery Standing Committee to confirm the minutes of this meeting.

## 5. MISSION SPOT

Revd Alison Gilchrist, Presbytery Minister – Mission, introduced Rosalie Tanner, a member of the Maylands-Mt Lawley Congregation, to speak about "Visual Evangelism", using buildings and other built structures as a canvas on which to place signs and symbols that speak of the faith. Rosalie is a graphic designer whose major client is Kings Park. She did the exterior design of the new St Andrew's in East Perth.

# **6. PRESBYTERY STANDING COMMITTEE** (Revd Lorraine Stokes, past chair, presiding)

The Chairperson of Presbytery, Bob Hunt, presented the Standing Committee report.

The Chairperson updated the report:

- (a) The Call to the Revd Dr David Ferguson of Kingaroy, Queensland, to the placement of Presbytery Officer has been accepted.
- (b) Joint Nominating Committees are being formed for the approved vacant placement of Rural Resource Minister (chair, Revd Lorraine Stokes) and Presbytery Minister Formation and Discipleship (chair, Revd Bev Fabb).
- (c) The Presbytery Standing Committee's future plans include more direct contact with congregations and faith communities. General requests for visits can be made to the Chairperson or Secretary
- (d) The Presbytery Standing Committee has scheduled a Planning Day on 7 March 2020.

There were no questions and the report was received.

Discussion points included:

- Property reviews involve 200 plus properties.
- Congratulations to St Andrew's on the great outcome of its redevelopment.
- Thanks to Mobile mission maintenance for work on the Mundijong Church (other congregations please note)

## **6A. WHO ARE THE PRESBYTERY STAFF 2020?**

An appendix to the Presbytery Standing Committee report detailed and introduced the people who will be the Presbytery staff in 2020 (noting that there are two position still to be filled).

The Chairperson invited those staff members present to stand and they were welcomed.

## 7. CANDIDATES FOR THE MINISTRY COMMITTEE

The report was presented by Margaret Donovan.

Margaret advised that 2 new candidates for the ministry had been accepted following the recent Selection Panel, bringing our candidates in various stages of formation to a total of five and more are expected next year.

There is a need for more mentors for those in a Period of Discernment, there now being 16 people enrolled.

## 8. TREASURER'S REPORT

Ps Marilyn Price presented the report for the period ending 30 September 2019.

At that date, there was a favourable balance against the budget of \$299,856, largely due to staff vacancies, and although two of these have been filled since 1 August 2019, the majority of the favourable balance will carry through the remainder of the year.

Mission and Service income has improved following recent contact with Congregations, and is only \$3,000 below budget.

Donald Nicholas, Uniting Church in the City representative, explained their situation – loss of tenants in the tower block has reduced their income and consequently their contribution (which is the largest contribution to Mission and Service by far). Donald advised that the UCIC contribution will be increased if tenancy income increases during the year.

Discussion about Mission and Service contributions included how best to inform Congregations about the level of responses that are expected. Freewill giving was affirmed, but the Presbytery lacks data to guide its planning. The question was asked, should congregations supply their budget?

It was suggested that Presbytery Standing Committee should develop a more rigorous and definitive way of promoting, receiving and reporting on Mission and Service, perhaps a new system in new year. There is a need more communication with congregations and a need to gather information from congregations for both financial and pastoral purposes.

Revd Lorraine Stokes moved, Bob Lockley seconded, and it was resolved:

that the Presbytery request the Standing Committee to develop a process for congregations to report their financial position to the Presbytery annually.

## 9. PRESBYTERY BUDGET 2020

Ps Marilyn Price presented the proposed Presbytery budget for 2020

Questions asked about student costs: these are living allowances for 5 candidates and total \$133k.

Ps Marilyn Price moved, Revd Bev Fabb seconded, and it was resolved:

That the Presbytery adopt the 2020 budget as summarised below:

- We educate for discipleship to enable the mission of the Church.
- We provide continuing, accessible education for lay and ordained ministry which strengthens missional leadership
- We provide formation for ordinands fit for ministry leadership in the 21<sup>st</sup> Century.
- We work collaboratively with other UCA colleges to provide complementary education and training through resource sharing.

## 16. THRIVE MISSION COMMITTEE

The report of the Committee was presented by Revd Greg Ross.

Greg advised that Revd Narelle Collas has resigned from the Committee and that Rhod Wright had been co-opted.

Following the Presbytery request in 2018 for every ministry agent and Church councillor/elder to complete the Mission Shaped Ministry by the end of 2020, registration forms for next year are now available.

A Property Advisory Group has been set up.

## 18. OPEN FORUMS

The first topic was: Regional Gatherings

- some have been just old Presbyteries continuing
- rural retreat model -- not as frequent but longer

- regional leadership to gather people together
- knowing members of Presbytery displaying roll
- Uniting Church its name is its mission
- costs and time for travelling and the tiredness of an ageing Church are issues today in many rural areas
