



# Minutes of the Meeting of the Presbytery of Western Australia at Billabong Uniting Church on 9 November 2024

### 1. Constitution

On Saturday 9 November 2024 at 9.00 am, the Presbytery of Western Australia met at All Saints Floreat Uniting Church with the Chairperson, Alison Xamon, presiding.

There were 31 ministers, 5 pastors, and 43 lay members present. Apologies were received from 10 ministers and 14 lay members. There were 4 visitors who attended.

### 2. Welcome and Opening Prayer

The Chairperson, Alison Xamon, welcomed members, especially those attending their first meeting and opened in prayer.

### 3. Worship Music

Rev Luke Williams and Billabong musicians led the Presbytery in beginning the meeting by singing our praise to God.

### 4. Welcome to Country

Rev Mitchell Garlett welcomed the Presbytery to Whadjuk country.

### 5. Opening worship

The Opening Worship was led by the Chair of Presbytery with Rev Mervyn Anderson preaching on the text of Ephesians 4: 1-6 and our theme of In Unity of the Spirit. We concluded worship with praise of God through song led by Rev Luke Williams and the Billabong musicians.

### 6. Community Building and Prayer

Members of Presbytery met in small groups for sharing about congregational life and prayer together.

### 7. Meeting arrangements

The Secretary, Rev Reuben Edmonds, presented Proposal 1 about the arrangements for this meeting.

### 8. Chairperson's Report

Past chairperson, Rev Lorraine Stokes, took the chair.

Alison Xamon presented a verbal report. She expressed her appreciation for the staff of the Presbytery office and noted that work is underway to fill the vacant Mission minister position. While continuing to support struggling congregations the Presbytery is also looking at ways to support growth in those congregations with the potential to do so. Alison highlighted the challenges of the truth-telling that is needed in congregations about leadership roles and those who may need to step down as they can no longer fulfil the role to the capacity needed. Alison highlighted the need for greater support from the Presbytery for Congress, particularly at this time.

A suggestion was made from the floor that term limits for leadership roles would be helpful.

The report was received by consensus.

The chairperson, Alison Xamon, resumed the chair.

### 9. Uniting Generations Network report

Pastor Julie Ridden presented the report and highlighted the need to update the information on the Presbytery website about the activities related to children, families, and young adults. Members were encouraged to provide updates on the sheets provided on their tables.

A question was raised about the progress on connections between the Uniting Generations Network and Intercultural Network. Julie spoke of her current efforts and hopes for greater connection.

The report was received by consensus.

### 10. Candidates for Ministries Committee report

Rev Bev Fabb presented the report. She highlighted that there are now very few people completing a Period of Discernment. Presbytery members are encouraged to keep an eye out for people who could participate in a Period of Discernment. It is a joy that there are a large number of people working to become Lay Preachers.

There were no questions, and the report was received by consensus.

### 11. What is Presbytery Booklet

Rev Bev Fabb spoke about the What is Presbytery booklet which has been reviewed and updated. Congregations will all receive a hard copy of the booklet in the next mailout, and it can be found on the Presbytery website.

### 12. Proposal 2- Recognition of Lay Preacher

Rev Bev Fabb on behalf of the Candidates for Ministries Committee presented the following proposal and invited Richard to address the Presbytery.

That the WA Presbytery agrees to recognise Richard Hugman as a Lay Preacher and request the Chairperson of Presbytery to arrange for this to be recognised in a service of worship, including presentation of a Certificate of Recognition as a Lay Preacher.

### 13. Congregational Selfies

A video was shown with highlights of the work at Wanneroo Crossways Uniting Church.

### 14. Secret Ballot on Proposal 2

After the congregational selfie, the Presbytery broke for morning tea. No questions were asked of CMC in relation to the proposal. The Presbytery voted on the proposal via secret ballot.

After the scrutineers counted the votes, it was announced that the proposal had received the two thirds majority required. Rev Stephen van Schalkwyk led the Presbytery in prayer for Richard.

### 15. Covenanting Discussion

Rev Alison Longworth began our discussion by giving an overview of the history of covenanting between the Uniting Church in Australia and the Uniting Aboriginal and Islander Christian Congress (UAICC) and in particular the history of this covenant in WA. Members were asked to consider the following questions in their table groups. Is there anything new that you have learned about the covenant today? How well has your congregation been supporting the Covenant with UAICC? What practical ways could you and your congregation support the Covenant with UAICC?

Answers to these questions were recorded and will be reviewed by the Presbytery Standing Committee.

### 19. Commission for Education for Discipleship and Leadership (CEDAL) report

Dr Karen Flowers presented the report. Planning for 2025 is already underway and a calendar of events is being drafted. CEDAL is reviewing events from 2024, especially those that had to be cancelled.

There were no questions, and the report was received by consensus.

### 20. Thrive Mission Committee report

Yvonne Robinson presented the report. She highlighted the large absence left by Rev Rob Douglas but the committee is working hard to continue his work. Thrive is seeking to work more closely with CEDAL and Uniting Centre for Education and Formation (UCEF), particularly in relation to Mission Shaped Ministry courses.

There were no questions, and the report was received consensus.

### 21. Presbytery Property Committee report

There was no one available to present the report.

### 22. Rural and Remote Ministry Network report

Yuko Tonai-Moore presented the report. She highlighted that the network is meeting regularly and seeks to share the ways God is working in our rural and remote congregations. All are welcome to join these meetings. It is wonderful to have staff support, from Rev Craig Bosman, after several years without it.

There were no questions, and the report was received by consensus.

### 23. Intercultural Network report

Rev Judy Sanderson presented the report.

Janine McDonald, Presbytery Treasurer, presented the Finance Report.

### 25. Proposal 3 Adoption of Presbytery Budget 2025

Janine presented the 2025 budget including a summary of the total budget and a breakdown by cost centre. The presentation also included visual pie charts of the Presbytery income, expenses, and expenses by cost centre.

Passed by consensus.

### 26. Proposal 4 Dissolving of Congregations and Recognition of Faith Communities

Sue reminded members that all congregations in this proposal have been fully consulted and are fully informed about the proposal coming today.

Concerns were raised about who will be the responsible body for the property. Members were reminded that faith communities can oversee their resources including property.

A question was raised about the responsibility of the church council for the congregation who holds the roll for a faith community. This is a two-way relationship and an evolving space as more congregations may be asked to take on faith communities.

Sue Strutt moved the following proposal:

### That the WA Presbytery agrees:

- 1. To dissolve the following congregation according to Regulation 3.4.3 as they are no longer able to carry out the responsibilities of a congregation.
  - Tambellup
- 2. To dissolve the following congregations according to Regulation 3.4.3 as they are no longer able to carry out the responsibilities of a congregation and recognise them as faith communities according to Regulation 3.9.2
  - Augusta
  - Darkan
  - Dumbleyung.

Passed by consensus.

### 27. Proposal 5 Appreciation

Tevita shared with the Presbytery some of the history of the Fijian Fellowship, where it is located, and the dream of creating a home in the Hedland Uniting Church property.

Rev Claire reflected on the joy of visited the community up in Hedland. Claire especially thanked Rev David Jackson for all his support for the Fijian community and their discernment journey to become a faith community.

Sue Strutt moved the following proposal.

### That the WA Presbytery agrees:

- 1. To recognise the Port Hedland Fijian Fellowship as the Hedland Fijian Faith Community of the UCA Presbytery of WA according to Regulation 3.9.2.
- 2. To welcome and encourage this new Faith Community to the life and witness of the Presbytery of WA.

Agreed by consensus.

Rev Claire led the Presbytery in prayer for the new faith community.
