

**Minutes of the Meeting
of the Presbytery of Western Australia
at Mt Pleasant Uniting Church
on 21 June 2025**

1. Constitution

On Saturday 21 June 2025 at 9.00 am, the Presbytery of Western Australia met at Mt Pleasant Uniting Church with the Chairperson, Alison Xamon, chairing the meeting.

There were 28 ministers, 3 pastors, and 49 lay members present. Apologies were received from 13 ministers, 4 pastors and 12 lay members. There were 9 visitors who attended.

2. Welcome & Lighting Christ Candle

The Chairperson, Alison Xamon, welcomed members and opening the meeting with prayer.

Alison began the meeting by lighting the Christ candle.

3. Welcome to Country

Rev Robbie Jetta welcomed us to country in language.

4. Opening Worship

The Opening Worship was led by the Chair of Presbytery. Rev Marie Wilson read 1 Kings 19: 1 – 15. Rev Steve Francis preached on 1 Kings 19: 1 – 15 and the theme of our meeting 'The still, small voice of God'. He reflected on how we could learn from the Trappist monastic tradition about silence, reflection, and listening to God. He reflected on a balanced Christian life, between worship and receiving and giving and service. How can we hear the whispers of God in the silence that call us to discipleship and service?

5. Community Building and Prayer Together

Alison welcomed those attending their first meeting and refreshed the Presbytery on the meeting procedures. Rev Sione Lea'aetoa introduced members to the Mt Pleasant Uniting Church building and highlighted relevant amenities.

Rev Sione Lea'aetoa informed members that sadly Presbytery member Brian Gluestein from the Mt Pleasant congregation died on Sunday after a period of illness.

Rev Sione led the Presbytery in prayer for Brian, his family, and the church.

Members of Presbytery met in small groups to share about congregational life and praying together.

6. Meeting arrangements

The Secretary, Rev Reuben Edmonds, presented Proposal 1 about the arrangements for this meeting.

The Presbytery agreed by consensus:

- 1. To adopt the Roll of Presbytery as available on the Presbytery Meetings website as the members of Presbytery for the 2025-2026 year.***
- 2. Adopt the Order of Business for this meeting.***
- 3. Appoint Rev Sophia Lizares and Rev Steve Francis as Chaplains for this meeting of the Presbytery.***
- 4. Appoint Sue Whitworth as Returning Officer, Rev Ken Devereux as Deputy Returning Officer, and Rev Craig Bosman and Mary Riley as scrutineers for this meeting of the Presbytery.***
- 5. Authorise the Presbytery Standing Committee to confirm the minutes of this meeting of the Presbytery.***

7. Chairperson's Report

Past chairperson, Rev Steve Francis, took the chair.

Alison Xamon presented her report. She reflected on the journey the Presbytery has undergone over the last 4 years of her leadership of the Presbytery. She highlighted while the workload has been high, this has put the Presbytery in a great position and will be a lower workload for the future chair of Presbytery.

The report was received by consensus.

The chairperson, Alison Xamon, resumed the chair.

8. Treasurer's Report

Janine McDonald, Presbytery Treasurer, presented her report.

Janine highlighted that the current financial position of the Presbytery is favourable and thanked those congregations who have submitted their finances.

The report was received by consensus.

Alison thanked congregations for their generous mission and service giving that enables the work of the Presbytery.

9. Candidates for Ministries Committee report

Rev Bev Fabb presented the report.

Bev highlighted the people that CMC has journeyed alongside. She encouraged members to continue to raise awareness about the possibility of a Period of Discernment. She reminded members that Lay Preaching training is now available online and can be completed anywhere and at candidates own pace. With joy she welcomed Kevin and Conrad as newly accepted candidates. Bev thanked the members, in particular Rev Toby Keva who is stepping down after 7 years on the committee.

The report was received by consensus.

10. Proposal 2 Recognition of Lay Preacher

Rev Bev Fabb on behalf of the Candidates for Ministries Committee presented the following proposal and invited Megan to address the Presbytery.

That the WA Presbytery agrees to recognise Megan Reynolds as a Lay Preacher and request the Chairperson of Presbytery to arrange for this to be recognised in a service of worship, including presentation of a Certificate of Recognition as a Lay Preacher.

11. Uniting World EOFY Appeal Video

A video from Uniting World about their end of financial year appeal was shown. The meeting then broke for morning tea.

12. Secret Ballot on Proposal 2

No questions were asked of CMC in relation to the proposal. The Presbytery voted on the proposal via secret ballot.

After the scrutineers counted the votes, it was announced that the proposal had received the two thirds majority required and Proposal 2 was passed. Rev Andy Broadbent led the Presbytery in prayer for Megan.

13. Recognition of Completion of Phase 3

This business was postponed to November as Rev Mitchell Garlett was an apology due to an emergency.

14. 2026 NCLS Presentation

Yvonne Robinson was an apology due to a family emergency so Rev Stephen van Schalkwyk presented on the National Church Life Survey that will be run in 2026. Congregations are encouraged register and to get as many people to participate as possible. If the cost is prohibitive, congregations are encouraged to seek financial assistance by contacting Thrive or the Presbytery.

15. Greetings from National UAICC

Interim Co-Chair Rev Ken Sumner brought greetings from the National Uniting Aboriginal and Islander Christian Congress. He reflected on the covenanting conversation he had with the Rural and Remote Ministry Network yesterday.

16. Changes to Code of Ethics

Rev Dr Andrew Williams highlighted recent changes to the Code of Ethics (3.1 (h) & (i)) which makes it clear that retired Ministers and Ministers who are in a non-congregational placement should not normally worship in a congregation in which they have previously served in a ministry placement. Recognising that there may some cases where this expectation causes undue hardship to the Minister or their family, the updated CoE allows for a Minister to consult with the Presbytery and any Minister currently in placement within the congregation in question regarding their ongoing worship attendance.

This change comes into effect as of the 1st of July 2025.

17. Inform and prepare for September Synod: Proposed changes to Proceeds of Sale policy (Embargoed Funds)

David Beards presented an overview of the proposed changes to the proceeds of sale policy (embargoed funds) ahead of the Synod meeting where it will be presented for decision. This policy will apply to current and future embargoed funds.

The new policy seeks to prioritise congregations to make it easier to understand and use. Proposed that embargoed funds will be aggregated into a Property Development Fund which all congregations will be able to apply for funding to purchase or lease a new property or significant renovations to existing property that enhances the mission of the church.

Question raised about support for ongoing maintenance however David explained that this is not a purpose that embargoed funds can be used for and so the new policy will not address it either.

Question raised about existing embargoed funds. David noted that the existing policy allows for embargoed funds older than 5 years to be moved into a central fund. The new policy will include all embargoed funds (both existing and future). It is hoped that the new policy will make it easier for congregations to access these funds.

Question raised about the existing policy's capacity for interest to be used for ministry and whether the new policy will allow this. Unlikely however this kind of support could be accessed through the Future Mission Fund instead.

A question about the funds for congress. David affirmed that any future proceeds of sale will still allocate 1% of sale funds to Congress and 9% to property services and the remaining 90% would go into the Property Development Fund.

18. Frontier Services Presentation

Montarna Cohen and Shontell Peawini presented to the Presbytery about the work of Frontier Services and how congregations can connect and get involved in the work of the agency. Rev David Jackson also shared about his ministry in the Pilbara and the impact it has on the local communities and his joy at the upcoming opening of the Port Hedland Uniting Church for the Fijian Hedland Faith Community.

Time for mic minutes was offered for members to share news about the life of our congregations and upcoming events.

The meeting broke for lunch after Rev Ana Lea'aetooa said grace.

19. Distribution of Ballot Papers

Sue Whitworth, the Returning Officer, thanked those who had nominated for vacant positions. The ballot papers for the election of the nominees were distributed and collected.

20. Chair of Presbytery Vacancy

Rev Reuben Edmonds updated the Presbytery on the next steps given there is no nominee for the chair of Presbytery position.

Alison Xamon is at the end of the maximum allowed term for a Chairperson of the Presbytery in the Rules of the Presbytery of WA. As such she is not eligible to nominate again.

The nominations committee has searched for several months to find nominees for the chair of Presbytery and despite several conversations no nominees were presented to the PSC.

As a result, at the June meeting of the PSC, we turned to the regulations, in particular Regulation 3.6.2 (d) which states “If the position of chairperson falls vacant, the duties of chairperson shall devolve upon the most recent former chairperson of the Presbytery and, if no such person be available, the Moderator of the Synod shall appoint a chairperson. In either case such person shall serve until the Presbytery is able to meet and elect a chairperson.”

While Alison will continue to support the Presbytery as a past chairperson she does not have the capacity to fulfil all the duties of the chairperson.

With gratitude, the moderator has accepted the task to appoint a chairperson for the Presbytery until our next meeting in November.

Presbytery members are urged to discern whether they are called to the ministry of Chairperson of Presbytery.

21. Pastoral Relations Committee report

Sue Strutt presented the report.

Sue emphasised the work of PRC which includes reaching out to congregations, sometimes at the request of a congregation and sometimes in response to reports received such as the health and vitality toolkit. PRC also works alongside the other committees of the Presbytery. Sue thanked those members of PRC who are stepping down and called for people to join the committee. Sue encouraged congregations to reach out if they are looking for support.

A concern was raised about the wording used, particularly the use of termination.

The report was received by consensus.

22. Committee for Education for Discipleship and Leadership (CEDAL) report

Dr Karen Flowers presented the report.

A question was raised about ACT 2 and how it might impact on WA. Rev Dr Cathie Lambert highlighted the new commissions that have now been finalised and new assembly staff have been appointed.

The report was received by consensus.

23. Thrive Mission Committee report

Rev Stephen van Schalkwyk presented the report.

Stephen highlighted the excitement of Thrive at the appointment of Rev Ana Lea'aetua as Presbytery Minister Mission supply and Rev Luke Williams as Presbytery Minister Mission from mid-August to support the work of Thrive. He highlighted the 25 Year Mission and Property Strategy for the WA Presbytery report is now 2 years old and Thrive is reviewing the progress so far in implementing it. Stephen also highlighted the upcoming workshops with Rev Ali Boulton.

A question was raised about whether any news hubs had been formed. Stephen highlighted that a number of clusters were discerning new paths forward towards hubs and other models.

The report was received by consensus.

24. Presbytery Property Committee report

Heather Hamblin presented the report.

Heather highlighted the joy of the work of the committee as contact is made with congregations and hearing how they are journeying.

A question was raised about congregational responsibilities regarding property. Heather said that a clear document outlining these responsibilities is nearing completion and hopes it will be available soon.

The report was received by consensus.

25. Uniting Generations Network report

Pastor Julie Ridden presented the report.

Julie highlighted the newsletter as a great way to find out about available resources. She welcomed feedback on the network meetings.

A question was raised about the Uniting Generations fund and the amount of interest. Julie highlighted that the various grants and encouraged congregations make applications.

The report was received by consensus.

Julie thanked Rev Kim Francis for her leadership as convenor of the network as she is now stepping down.

26. Rural and Remote Ministry Network report

Yuko Tonai-Moore and Rev Craig Bosman presented the report.

Yuko highlighted the ongoing work of the network and the mutual support it provides to its members. Craig reflected on the talk by Rev Ken Sumner to the Rural and Remote Ministry Network yesterday and thanked South Perth Uniting Church for hosting. He also thanked Richard Hugman, David Jackson, and Yuko for helping to organise the event.

There were no questions, and the report was received by consensus.

27. Intercultural Network report

Rev Judy Sanderson presented the report.

Appreciation was expressed for the work of Judy in organising and running the 40 year anniversary service of the statement 'We are a Multicultural Church'.

It was highlighted that all congregations are intercultural and they are encouraged to explore the many cultures within their congregations and engage with the intercultural network. Judy highlighted that we can not just be intercultural with some cultures but must be open to all.

The report was received by consensus.

28. Strategic Priorities Update

Rev Reuben Edmonds presented the report updating the meeting on the progress of the Presbytery towards the key priorities that they are responsible for.

A question was raised about how the Presbytery can support the covenanting committee as significant anniversaries of colonial settlement in Albany, Fremantle and Perth approach in the next few years.

Rev Bev Fabb responded that this suggestion will be taken back to the covenanting committee. The Covenanting Commission is also intending to write to congregations with some suggestions of how they can engage in covenanting, to supplement the Congregational Covenanting Guide which is available on the UCA website.
